This farmstead, located on a knoll above Rich Branch, sits far back from DuFief Mill Road. Buildings include the farmhouse, bank barn, smokehouse and chicken house. It is one of a handful of farms left in the highly developed North Potomac area. While the bank barn is a well preserved example of its building type, the farmhouse has lost much of its original integrity. The house, although originally noted as the F.J. Hurle Farm, was probably built by Basil Thomas Henley about 1884. Mary C. and Franklin J. Herrel lived here from 1887 until 1901. May Baughman was responsible for major improvements to the property after she purchased it from the Herrels. After Baughman sold the farm in 1940, it went through a succession of owners until the present owner bought it in 1963.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Basil Thomas Henley Farmstead, located on a knoll above Rich Branch, sits far back from DuFief Mill Road from which it is accessed by a long, narrow, paved drive. Pastures on both sides of the drive are enclosed with white paddock fences with diagonally braced gates. Buildings include the farmhouse, bank barn, smokehouse and chicken house. The sixty acre farm is surrounded on the south, north, and west sides by subdivisions and backs up to the Big Pines Local Park on the east, off Travilah Road. The natural setting is an important part of the character of the property.

The frame farmhouse was built in many sections. The original block, built c1884, was a three bay I house facing west. A rear ell extends from the southmost section of the east facade. The rest of the east facade and north facade are extended by later two story additions. A one story ell extends to the north. The front gable roof and rear ell are covered with standing seam metal. Other roofs are composition shingle. While the west facade is covered with drop (German) siding, other siding is wide clapboard.

The main side gable block is a three bay, two story, I house which faces west. Windows with shutters are six over six sash on the first level, and two over two on the second. The foundation is Seneca sandstone. The central entrance, with paneled door, four pane sidelights and Colonial Revival broken pediment, is accessed by a small concrete stoop with metal railing reached by short flights of side steps. Internal chimneys stand on the north and south ends.

At the north end of the main block is a two story, three bay addition with six over six sash at the second level and a three part picture window at the first. A small, one story, side gable hyphen at the north end of this addition connects it to a one story, one bay, front gable addition with a large, multipane window in the west elevation. All additions are recessed from the main block, particularly the northmost one.

Extending from the southmost part of the main block's rear (east) facade is a lower two story, two bay, gable roof ell which may have been built c1902. Windows are six over six sash and there is an internal chimney at the ridgeline. A one story, shed roof greenhouse covers the westmost bay of the south elevation. Adjacent to it, to the east, is a long, one story, gable roof enclosed porch with large windows on the south elevation. Entrance to the porch is from a glass-paneled door with a tracery fanlight and sidelights on the east (rear) elevation and sliding glass doors in the north elevation. There is also an entrance from the rear of the north-most wing, through another paneled door with tracery fanlight and sidelights. A stone patio stretches across the rear of the house and there is a pool just beyond the patio.

The entrance at the east elevation of the rear porch is now the main entrance to the house, replacing the original entrance on the front (west) elevation, which is difficult to access because of a steep slope and large trees. The driveway which once led to the front entrance now extends to the rear entrance instead.

According to the current owner, William Thomas Reed III, the porch (originally only screened-in) at the east end of the rear ell and the wing immediately to the north of the main block (originally one story) were added in 1948. Mr. Reed, who acquired the property in 1963, added the second story to the front wing in 1983, enclosed the porch at the rear, added the glass doors on the north elevation of the porch, erected the greenhouse at the southwest corner of the rear ell, and reconstructed the chimneys.

To the rear (east) of the house is a group of outbuildings, including a modest size, two-bay bank barn with a corrugated metal roof, vertical wood covering, three louvered windows in each gable end, and a foundation of Seneca sandstone. Only one louvered cupola, in poor condition, remains of the two which originally stood on the east and west gable ends of the roof ridge. On the north elevation is a large overhead door with a small door in its west side and a small six-light casement window in the west-most bay. Across the width of the south elevation is a one-story, one-bay, shed-roof addition.

To the east of the barn is a metal sided garage, erected in the 1980s. North of it stands a one bay, front gable smokehouse with a raised seam metal roof, board and batten siding, and a vertical wood door with metal strap hinges. The smokehouse is now used for storage. West of the smokehouse is a one story, two bay, board and batten covered, shed roof chicken house with a single six over six, double hung sash in the eastmost bay. The southeast corner has a small addition and there is a large, open, shedroof addition to the rear. The structure is now used as a storage shed/pool house.

The bank barn, smoke house and chicken house are contributing structures.

Summary: The Basil Thomas Henley Farm is one of a handful of farms left in the highly developed North Potomac area. While the bank barn is a well preserved example of its building type, the farmhouse has lost much of its original integrity.

The house was probably built by Basil Thomas Henley about 1884. Henley paid \$504 for 63 acres of unimproved land from the estate of William West, deceased, in November 1883.¹ The construction date is inferred from the additional evidence that Henley sold the house in 1887 for more than twice the purchase price. Henley may be the Thomas Henley who, by 1879, lived where Travilah Road (formerly Piney Meeting House Road) met the Sandy Branch, three-quarters of a mile due south. Thomas Henley was again (still?) at that location by 1894.²

Mary C. and Franklin J. Herrel lived here from 1887 until 1901, when they defaulted on their mortgage.³ May Baughman was responsible for major improvements to the property after she purchased it from the Herrels. The rear two story addition of the house may have been built at this time (c1902).⁴ After Baughman sold the farm in 1940, it went through a succession of owners until the present owner, William Thomas Reed, III, bought it in 1963. The farm is now known as Amberlea.



There are several sheds and a bankbarn east of the house. All have stone foundations and framed structures. The sheds have board-and-batten sheathing.

The F.J. Hurle farmhouse is significant as an example of the small farms representative of the later settlement of the Potomac-Travilah area. The house was probably built by Basil Thomas Henley about 1884.¹ Basil had purchased 63 acres of unimproved land in November of 1883 for \$504 from Julian Brewer, trustee in the sale of the estate of William West, deceased. The 63 acres was part of a larger farm.

In June of 1887, Basil and his wife, Cecilia, sold the property to Mary C. Herrel, wife of Franklin J. Herrel (not F.J. "Hurle") for \$1260.³ In 1901, the house was sold by trustee, the Herrels having defaulted on their mortgage. The property was purchased by May L. Baughman for \$1362.⁴ The assessed value of the house doubled between the years 1902 and 1903; this may have been the date of the rear addition.⁵ May sold the house in 1940 and it went through a succession of owners until it was purchased in 1963 by William T. Reed, III, the present owner.⁶

This property is a very good example of the small farms that marked the late settlement of the Potomac-Travilah area. (The area was, of course, settled from the 18th Century on- however, most of the houses seen today are from this later, heavier occupation.) The houses erected here during the late-19th Century have a marked similarity, and the barns especially are smaller, attractive examples of Victorian design.

This place appears on Hopkins' 1894 map as the F.J. Hurle (possibly Hurley?) farm of 63 acres. It does not appear on earlier maps.
