This Queen Anne/Eastlake cottage is believed to have been designed by master-builder Edwin M. West. Its corner turret with imbricated pattern shingling and conical wood shingled roof, its jigsawn and bracketed porch and the use of a "Rockville Bay" are duplicates of architectural elements West used in other buildings in Rockville. Now used as a law office, it is nearly original in appearance.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

This 2½ story Queen Anne style Victorian is situated on the corner of Jefferson and South Adams Streets, facing west. The roughly square 3 bay by 2 bay frame house has a hipped main block section, with an intersecting rear cross gable; both are covered by black asphalt shingle. Resting on a rubblestone foundation and sheathed in aluminum siding, the house features a two-story southwest corner tower with a steep conical roof.

The round corner tower rests on a three-bay square base which projects outward at a 45° angle. The fish-scale shingled second floor is topped by a cedar-shingled conical roof. The west (front) facade has a full-width shed-roofed porch with turned posts and decorative brackets. A wood and glass paneled door is positioned in the north-west bay, and paired, one-over-one windows are located in the center bay of both floors.

The south facade adjoins the corner tower and features a 2½ story gable end bay at the southeast corner. Fish-scale shingles surround the square attic window. There are two 2-over-2 second floor windows, and on the first level is the mitred "Rockville bay" with decorative dropped pendants and curved brackets.

Most windows throughout the house are two-over-two double hung wood sash with louevered shutters. Both the west and the south facades abut a concrete sidewalk.

The north facade repeats the fish-scale attic shingles at the opposite end of the gable. A diamond-shaped window lights the stairs. The east (rear) facade has a brick chimney, a box-like central two story projection, and a one-story shed-roofed enclosure on brick piers.

Moderately scaled in its proportions, 14 South Adams is composed of several architectural features which enjoyed great popularity in Rockville in the late 19th century. These features often were employed on homes of a slightly larger scale, but they have been adapted successfully in this cottage, which is now used for law offices.

Prepare both a summary paragraph of significance and a general statement of history and support.

This 1889 turreted cottage is highly visible at the corner of Jefferson Street and South Adams. It was built for Bessie Lyddane by her parents, Judge Stephen Lyddane and his wife Sarah Braddock. The Braddock/Lyddane families owned the east side of this block for 100 years, and played important roles in the commercial, political and judicial history of the Town.

Stephen M. Lyddane, Judge of the Orphan's Court and five term County Commissioner, died in September, 1889.¹ At the time of his death, Judge Lyddane was in the process of building a new store and two dwellings, and the records of payments owed to the contractors for lumber, bricks and plumbing work are listed in his estate accounts. One of the houses under construction was #14 South Adams. Judge Lyddane left a widow and four daughters, all of whom were married except 25 year old Bessie. Two months before his death Judge Lyddane and his wife Sarah Hilton Braddock Lyddane deeded this lot (#69 of the original Town of Rockville) to Bessie "for love and affection".²

The building contractor for the house is listed as R. A. Clagett; however the statement of accounts also lists payments owing to two other builders in Rockville, "Mr. West - \$130 for building" and "J. O. Isanogle - \$200".³ The record does not detail what work these builders were doing, but it is believed (based on a comparison of this house with Mr. West's other known works) that Edwin M. West may have supplied the plans and/or other work on the house. A examination of details of Mr. West's own house, then being constructed at 114 West Montgomery Avenue, shows marked similarities, particularly in the use of the "Rockville Bay" with its curved brackets and dropped pendant detailing; in the design, dimensions and shape of the cylindrical turret with cedar shake roof; and in the placement of the fish-scale shingling on the turret and gable ends. Mr. West also supplied lumber for gates at \$12.70.

Bessie Lyddane never lived in this house, but made her home with her mother at the northern end of the same block (fronting on Commerce Lane, now W. Montgomery Avenue), later she lived with the family of her sister, Mrs. Stephen Quigley.

Mrs. Lyddane, known as Sally, was the daughter of William Braddock, and had been born on this block; her father had owned parts of lots 69-73 since 1819.⁴ In 1828 the Maryland Journal and True American reported that "William Braddock opened a new grocery and feed store adjoining his home". In 1831 the paper advertised that Elizabeth Braddock was operating an ordinary. Sally Braddock married Stephen M. Lyddane in 1843 just a few years before her father's death. In 1849 while Stephen was serving his first term as County Commissioner, the Braddock heirs advertised "Sale-- William Braddock Store, at the old stand on Quality Hill". The store was owned by a succession of merchants, including those intermarried with the Braddock girls, until the Lyddane ownership in 1873.⁵

The 1878 Hopkins Atlas shows lots 69-73 with a tenant house and stable on the southwest corner of the block at the future site of #14. On the northwest corner lots of the block are the stores, shops, dwelling houses and stables of the Braddock/Lyddane families. These lots were then and are now commercial. The new store that Judge Lyddane was building in 1889 was later sold to Willis Burdette in 1911; it is now the site of the Dixie Pig Barbeque.

The Tax Assessment for 1910 valued #14 South Adams at \$200 plus \$1,200 worth of improvements. Sally Lyddane died in 1911 at age 84, and in 1919 Bessie sold her house to Frank Karn.⁶ The Karn family owned the property until 1956, and rented it to tenants during most of that period. Between 1956 and 1970 the house was owned successively by Herbert Wright and Lawrence Widemayer. Mr. Widemayer did the initial interior alteration and adaption of the house to serve as his law office. In 1970 Robert Jacques and Douglas Taylor bought the property, and did further work on the house. In 1976 the house was sheathed with narrow aluminum, corresponding to the narrow "German" frame siding underneath; the 19th century bracketing, turned pendants, lattice work, shingling and window treatments were retained. Mr. Jacques served in the Maryland House of Delegates from 1974 to 1978; he and Mr. Taylor currently occupy the building as their law office.

5. In 1890 Mrs. Lyddane purchased the M. Green house, fronting on Commerce Street, but this building lay further east of the old Braddock store/dwelling. Attached is a plat of 1911 sale of her estate; note that names used for streets are those used prior to 1803 plat of City. Judgment Record 8/410 (1890) and Judgment Record J.L.B. 11/321 (1911) review the histories of these properties.


