DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an unusually-large, estate-type of late Victorian building. It is of frame construction, and almost three full stories in height. There are several cross gables in the roof. The building is sheathed in German siding. It is painted white, with green trim, and sits on a wooded, landscaped knoll above Rockville Pike, along the RR tracks. A tenant-type house (built with similar materials, but much smaller in size) sits directly on Rockville Pike. It is two-stories, with a three-bay main (west) facade, and a raised, one-story open porch. The roofline has a low center gable here.

House probably dates from ca. 1900. It is one of the very few surviving large homes that once lined Rockville Pike. A close examination of the house was not possible at the time of this survey, but the structure reportedly was the home of Sprigg Poole, a prominent County businessman.
