Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

This large scaled 3-bay by 5-bay frame late Victorian house sits prominently on a rise on the south side of Maryland Avenue, facing north. The 2½ story, asymmetrically balanced clapboard house has a dominant slate-covered hip roof with projecting gables and two brick interior chimneys. The foundation is of fieldstone.

A Doric-columned deep, open verandah extends across the entire north and some of the east facade. On the main (north) facade, 3 steps lead up to the tongue-and-groove-floored, balconied verandah and the entryway. The front door is housed in a central box-like addition that abuts a northeast corner three-sided bay projection. Double five-panel doors with an arched transom are set in a molded and keystone frame. Above it is a second floor door which opens onto the verandah roof. In the center of the hipped roof above the entry bay is an attic dormer with diamond lights. The large projecting northeast bay is capped by a decoratively shingled pediment.

The verandah extends on the east facade to a similar projecting bay located near the center. It, too, has the shingled pediment and three-sided form. A small second floor porch with turned posts sits atop a closed-in rear entry at the southeast corner.

The west facade is composed of the hipped roof, 3-bay block which has a centered window flanked by two windows on each level. There is a 2-bay block to the rear.

All windows are one-over-one double hung with large lintels and louvered shutters. The main facades of this house appear to retain their original character, but the rear of the house has been altered by small modifications. A tiny garden building near the south facade looks onto the treed lot surrounding this handsomely detailed frame Victorian.

Prepare both a summary paragraph of significance and a general statement of history and support.

The house built for George Hunter in 1904 on "The Heights" is typical of the kind then being constructed for Rockville's most prosperous citizens. Its ample proportions suggest its spacious, high ceilinged rooms and its large windows and airy porches convey a feeling of light and grace despite its size. Many turn-of-the-century houses were balanced and symmetrical with neo-Georgian or Adamesque detailing like this arched and pillastered entrance; combinations of round, Palladian or diamond-paned windows were used. The large porch was retained from earlier styles, but carved brackets and turned spindles of the Victorian verandah were replaced by the Doric columns and plain fascia seen on this porch. This home on its spacious grounds has remained a comfortable residence for 80 years; its only exterior alteration has been the addition of the second floor railed deck.

Rockville Heights was platted in 1889/90 on the Carter farm at the southeast edge of the town. Although overall sales were slow, some of the most prominent citizens of Rockville built their new "Colonial" or "Edwardian" houses on multi-acre parcels. George and Hortense Hunter purchased four acres from the Carter heirs in December, 1903.¹ The newspaper reported the sale as well as plans to erect a commodious dwelling house on the site.²

The Hunter property encompassed the whole of Block 5 (except for lots 7 & 8) and was bordered by Maryland Avenue, Washington Street, Argyle Street and Adams Street. The Hunter family occupied the house until its 1946 sale to Charles W. Prettyman, but the Prettymans found the house too large and in 1949 sold it to Carl B. Hyatt, Judge of the Juvenile Court.³

The Hyatt family lived here until 1965. During that time the land was subdivided twice.⁴ Judge Hyatt and his wife built a smaller house at #14 Maryland Avenue for their residence, and another house was built on Argyle Street, both part of the original lot. The address of the subject house was changed from #12 to #18 Maryland Avenue. The Hyatts added the second floor railed porch.

From 1965 to 1968 Leonard and Ginetta Sagan owned the house. In 1968 it was sold to the present owners, Joseph and Mae Batz,


