DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This large frame house is cubical in form, two stories high, two bays wide by two deep, and faces northwest. The pyramidal roof exhibits considerable overhang, and the eaves are enclosed. A corbeled chimney exits from the apex of the roof, and a hipped dormer with a six-light casement window pierces the northwest slope.

The principal (northwest) facade has the entrance in the right bay, with a double 6/1 sash window to the left. Double 6/1 windows are aligned above these openings on the second floor. A one-story hip roofed porch runs across the front and wraps around the northeast side where it is enclosed with screening.


