9. Description: This three bay by five bay, two and a half story rectangular frame house has a rear ell and faces east. It is set back a considerable distance from the road. It has white clapboarded exterior walls. The east porch has a flat roof supported by four wooden posts and enclosed by a balustraded railing. There is a screened porch on the north elevation with a shed roof. There are two-over-two double-hung windows. There is a one story bay window at the southeast corner of the east elevation. On the east and south elevations there are hipped dormer windows. The house has a hipped roof with wooden shingles.

The mill was a frame structure which sat on a fieldstone basement. It had a steep gambrel roof, with a shed-roof addition on the west side. The race ran across the road into a wooden flume, and fed a wood overshot wheel. Nearby was an open-sided saw mill, sitting on high stone piers, which was fed by a separate race. The mill burned to its foundation about 1936; today four partially-collapsed walls remain. Traces of the race, dam, and mill-pond are visible.

10. Significance: Milton is important as the last working farm in this area of Montgomery County. The present late 19th century house stands on land that was first farmed by J. Elgar in the late 18th century. He also operated a mill here. George Robertson purchased 164 acres and added several tracts, creating a farm of 300 acres which he and then his son William farmed. The property was inherited by William's daughter, Rachel, who married Edwin W. Muncaster. In 1860 he passed on the farming operation to his oldest son William E, then age 21. The present house was constructed in 1897 to replace the 18th century homestead by John E. Muncaster, William E.'s son. The mill was operated into the 20th century but burned in 1936. The lands were sold out of the Muncaster family in 1929 as two separate tracts which were later bought by William R. Winslow, who enlarged and modernized the main house. The MNCPPC purchased the mill ruins from Winslow in the 1960s. The main property -- house, barns, log tenant house, and other outbuildings -- is now being subdivided for development.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The present house, built in 1897, replaced an 18th century, one-story log cabin with weatherboards. It was greatly enlarged and modernized in the 1930s. It is a large, two-story frame building with a square main block. A lower, smaller wing built onto the west side is of similar styling. Both sections have steep hip roofs and tall chimney stacks. The main (east) facade is three bays wide with a central door. An elevated, one-story open porch, topped by a balustrade, spans the front. A narrow, two-story, tower-like wing projects slightly from the south wall. Siding is clapboard. All in all it is a stylish country estate of unusual design.

There is a large number of notable outbuildings nearby. These include several large hay barns, with mortise and tenon framing, a stone meathouse with very old hardware, and a garage-type of shed on a stone foundation.

Southeast of the main house, near Flower Valley, is an abandoned and deteriorated two-story log tenant house with an old shingle roof and weatherboard siding. It has a three-bay main (south) facade, with a central door and a central brick stove chimney. It features elaborate, sawn bargeboards along the eaves.

The mill was a frame structure which sat on a fieldstone basement. It had a steep gambrel roof, with a shed-roof addition on the west side. A race ran across the road into a wooden flume, and fed a wood overshot wheel. Nearby was an open-sided saw mill, sitting on high stone piers, which was fed by a separate race. The mill burned to its foundation about 1936; today four partially-collapsed walls remain. Traces of the race, dam, and millpond are visible.

## STATEMENT OF SIGNIFICANCE

"Milton" is important as the last working farm in this area of Montgomery County.

J. Elgar farmed the land and operated a mill here in the 18th century before he sold 164 acres to George Robertson. Robertson purchased adjacent tracts in the 1790s to make a total of 300 acres, which he farmed with the help of slaves. Robertson's son William continued to farm the land after him; the property was then passed to William's daughter Rachel, who married Edwin M. Muncaster. Muncaster took charge from his father-in-law, and later passed the operation on to his oldest son William E., who took over in 1860 at the age of 21.<sup>1</sup>

The mill was operated into the 20th century, but burned in 1936. The present house was constructed in 1897 to replace the 18th century home-  
stead. It was built by John E. Muncaster, William E.'s son. In 1929 the Muncasters sold 325 acres with the house to John H. Smithwick,<sup>2</sup> and another 333 acres to Joseph C. Zirkel.<sup>3</sup> The tracts were reunited in the 1930s under the ownership of William R. Winslow, who enlarged and modernized the main house.

The M-NCPPC purchased the mill ruins from Winslow in the 1960s. The main property with the house, barns, log tenant house, and other out-  
building, is now being subdivided for development.

## STATEMENT OF SIGNIFICANCE

The continued survival of this farm is vital to the health of the nation's model Rock Creek Watershed program. This is the last working farm left in this area of Montgomery County. Its long and varied history is closely linked to the settlement and development of the Rock Creek Valley. Several mills were operated on the farm from the 1700's up until the 1920's. Soldiers visited the farm during the War of 1812 and the Civil War. The Robertson and Muncaster families owned the place for generations and led the County in many agricultural pursuits during those years. The last owner, Mr. W.R. Winslow (of the area's Winslow Paint and Hardware chain), was also quite active in early-20th Century agricultural activities, and had a show-place farm here. He died recently, and his will directs that the property be sold (presumably for development) in order to fund various charities.





IMPLEMENTATION

Once designated on the Master Plan for Historic Preservation, any substantial changes to the exterior of a resource or its environmental setting must be reviewed by the Historic Preservation Commission and a historic area work permit issued. The Ordinance also empowers the County's Department of Environmental Protection and the Historic Preservation Commission to prevent the demolition of historic buildings through neglect.

It is the intent of the Master Plan and Ordinance to provide a rational system for evaluating, protecting and enhancing Montgomery County's heritage for the benefit of present and future residents. The accompanying challenge is to weave protection for this heritage into the County's planning program so as to maximize community support for preservation and minimize infringement on private property rights.

THE AMENDMENT

The purpose of this Preliminary Draft Amendment is to consider the Montgomery County Historic Preservation Commission's recommendations that the following sites be designated on the Master Plan for Historic Preservation and protected under the County's Historic Preservation Ordinance, Chapter 24A of the Montgomery County Code. A copy of the Ordinance is provided in Appendix B of this document.

*(NOTE: Unless otherwise specified in the Preservation Commission's nomination, the recommended environmental setting for each site is the entire parcel on which the resource is located as of the date it is designated on the Master Plan as defined in Section 24A-2 of the County's Preservation Ordinance. Where additional buildings of historical or architectural importance are associated with a site, these buildings are noted in the nomination as being part of the recommended setting.)*

-	Dating from 1855 with a rear section added in the 1870's, this three-story house is distinguished by three over three windows on the third floor and a one-story porch with bracketed pillars on the front facade.	
-	Significant as an example of the "Spencerville style", a local style characterized by a special grouping of architectural detail most notably half windows on the third story extending into the boxed cornice and roof line.

Holland Store

16400 Layhill Road

- The store, built circa 1860, is one of the few surviving commercial structures of that era in the County. Although undistinguished architecturally, it contributes to the economic heritage of the County as an example of a 19th century, rural crossroads, general store.
- Has been a landmark at its present location -- earlier known as "Holland's Corner" -- for 125 years, including numerous years as the local post office.
- The recommended setting includes the major trees associated with the store.

Jacob Allnutt Farm

23601 Route 108

- Built in 1887, this two and one-half story frame house retains its original German siding, fish-scale shingles, chamfered posts, ornamental trim, and a wrap-around porch.
- Architecturally, the building is an outstanding example of Queen-Anne architecture with Eastlake features.
- Associated with the Allnutt family, the home was built by Jacob Allnutt, son of prosperous Laytonsville landowner, John Allnutt.

The recommended setting notes that none of the out-buildings are of any particular historic significance.

Milton II or

15512 White Willow Lane

Muncaster/Winslow Farm

- Site of a farmstead historically associated with the Robertsons and Muncasters, prominent County families closely linked with the early settlement and development of the Rock Creek Valley.
- Through much of the 20th century, the home of prosperous Washington area businessman W.R. Winslow, owner of the Winslow Paint and Hardware chain, who was active and influential in County agricultural organizations.
- Loss of the second manor house associated with the farmstead leaves the site architecturally represented by the only remaining outbuilding -- a fieldstone smokehouse situated on a 57,315 sq. ft. lot which constitutes the environmental setting for the site.
