EBP 20/106 Dec. 5, 1978; Warwick Stabler to John H. and Margaret Combashner for \$125; 5 acres; no improvements.

218/35, Jan. 24, 1911; John H. and Margaret Combashner to Dennis and Ashbury Williams; 5 acres; buildings mentioned.

18/341, July 19, 1916; Dennis W. Williams from Asbury and Mary Williams.

260/53, Sept. 23, 1916, to Samuel Moore from Dennis and Alice Williams.

1101/264, Sept. 25, 1946. Samuel Moore and Imirie B. Moore.

According to Mrs. Imirie B. Moore, 311 Bryant's Nursery Road, Silver Spring, phone 384-1665, this house was purchased as part of Norwood Estates and demolished by the owner. Researcher was unable to physically locate house at the location shown. A second person was contacted, Mrs. Gladys Patton, 774-7780, who lives near the location, and she confirmed the report of Mrs. Moore. Norwood Estates was subdivided by Harry E. Gorin and Louis Gorin (Plat Book 108/2504, 1980). This plat book does not indicate on which of the subdivided lots the old house stood, and neither Harry E. nor Louis Gorin can be located in the metropolitan area telephone book.
