STATEMENT OF SIGNIFICANCE

This was an important country grist and saw mill, that was associated with the nearby Magruder home "Locust Grove" for years. An old photo, ca. 1876, shows a primitive frame building, built on a high stone base-ment. Just beyond this was the saw mill, an open frame shed built on high stone piers. By 1915, only the grist mill stood-and it had been abandoned by then. The last owner to operate it was "Swedie" Williams, and 1940's Real Estate maps show him owning several buildings at this site (pos-sibly it stood as late as this.)
