9. Description: This country schoolhouse has been enlarged and converted into a private residence. It originally was three bay by two bay, one and a half story structure. The present owners added a second story, a northeast wing and two picture windows on the southeast elevation. The house has beige novelty siding at the first level and stucco at the second. There are two-over-two double hung windows, two large picture windows and six-over-six double hung windows. These are flanked by reddish brown louvered shutters. The gable roof has asbestos shingle covering.
10. Significance: Now incorporated into a larger residential structure, the Carroll School was once a one-room schoolhouse in the County's school system before consolidation. The "Great Falls" school on this site, constructed about 1873, was replaced in 1901 by the Carroll School. It served 40 to 50 children for 11 years until the Board of County School Commissioners in 1912 decided to consolidate it into the Potomac School. The building was sold in 1915 and converted into a residence. It has been owned since 1945 by Luther Butt.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a country school house which has been converted and expanded into a private residence.

Built on stone foundations, it was originally three bays by two bays and one story high. The present owner added a second story, an addition to the northeast, and two picture windows on the southeast elevation. This frame school house is painted beige and has novelty siding at the first level and stucco at the second level. The present owner added a porch to the northwest. This has poured concrete foundations, and a half-hipped roof supported by wooden posts. There is an outside end chimney on the southwest elevation.

The northwest (front) door is wooden paneled. It is surmounted by a nine light transom. On the northwest elevation there are two over two light double hung windows. There are two picture windows on the southeast elevation. The remainder of the windows are six over six double hung. All the windows and the southeast door are flanked by reddish-brown louvered shutters. The gable roof has asbestos shingle covering.

STATEMENT OF SIGNIFICANCE

The Carroll School, although incorporated into a larger residential structure, remains as a representative of the tiny schoolhouse available to rural Montgomery County before consolidation.

The "Great Falls" school was authorized by the Board of County School Commissioners in 1872, with \$300 appropriated toward its construction the following year.¹ It was a one-room structure, 33' by 26' in size, heated by a pot-bellied stove, and served children from farms in the area. It was built on land sold to the Commissioners in 1875 for \$28 by Luther and Charlotte Offutt, containing 30 and 3/4 square perches of land.²

By June, 1900, a replacement was requested and appropriated, and it was built in 1901. In 1902, Carroll School, described as 22' x 26', vestibule 4' x 8', takes the place of "an old building which has been removed"; it was insured for \$480.³

The school served some 40 to 50 children, who traveled by horse and wagon each day. The Commissioners agreed in 1912 to consolidate Carroll School into Potomac School, and did so on July 30. The building was offered for sale in March, 1914,⁴ and sold to Eugenia E. Bull on January 30, 1915, for \$305.⁵

Carroll School has had other owners since its conversion to a residence. Subsequent owners of Carroll School since its conversion to a residence include Charles and Eva Gooding, Joshua and Thelma Lynch,⁶ Vernon and Ruth Poston,⁷ and, since 1945, Luther Butt.

This present structure is now two stories, with a two-bay gable facade that faces east. There is an addition on the south that has a screened-in porch on the upper level. Most siding is German siding.</p>

STATEMENT OF SIGNIFICANCE

This is the last remainder of several one-room school-houses that were once located in the Potomac area. This is reportedly one of the oldest. Maps of 1878 & 1894 indicate a public school at this site. The name came from the Carroll family that owned the land nearby.


