DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This is the site of one of Montgomery County's most interesting early mills. The ruins are situated on the east bank of Cabin John Creek, about 100 yards north of River Road. The quarry operation cut into the steep hills here, and much of the rubble has been pushed over the ruins. A low stone wall (now overgrown) can be seen. The walls do not now contain any mortar. The creek bank below here shows traces of a stone flume, or outrace, that descends in steps to the water. There was a ruined, part-stone/part-frame house (reportedly associated with the mill) that stood on River Rd., on the west bank of the creek, until the road was widened within the past few years.

A popular spring is located a few yards east of here on River Rd. It is at the end of a footpath, and has a considerable following among the local suburbanites.

**STATEMENT OF SIGNIFICANCE**

This was reportedly a large stone merchant mill, built in the early 1800's by Patrick Magruder. The land, known as "Doull's Park", was patented as "Hobson's Choice" to Dr. James Doull in 1762. Patrick Magruder was a member of the Md. House of Delegates, a member of the U.S. Congress from Md., Clerk of the House of Representatives, and the Librarian of Congress. He was not as successful in his operation of the mill, however, as it changed hands several times. It was used as a paper mill at one time-the only one ever built in Mont. Co.-and reportedly burned about 1854.


