The Arnolda Estate is significant as an example of "Estate" architecture influenced by colonial styling, popular during the early part of the twentieth century. The house is believed to have been built about 1912 by Edwin Luther Wilson.<sup>1</sup> Edwin's house was built on ten acres of tracts of land referred to as "Addition to Wilson's Discovery" and "Dann" which he purchased in September of 1911 from the heirs of Benson Talbott, deceased.<sup>2</sup>

Edwin and his wife, Ettie, sold the house in June of 1926 to Kaniah M. Boteler.<sup>3</sup> The Botelers sold the house soon after buying it and it then passed through a succession of owners. The house was owned by Paul and Beatrice Neal for ten years (between 1937 and 1947).<sup>4</sup> Herbert and Gertrude Beswick also owned the house for many years (from 1954 until 1968).<sup>5</sup> Since 1969, the house has been the property of "Grosvenor Partnership."<sup>6</sup> It is presently being used as part of the "Bethesda Health Center" complex.
