Description:

The Ben Petree Property is a 2½-story cottage with bungalow features on the west side of the Old Columbia Pike in the Silver Spring vicinity, Montgomery County. Constructed circa 1920, the building is extensively altered and has a raised basement with a garage.

The structure has a side-gable roof with large shed dormers. The dormers, which are located on the front (south) and rear (north) elevations, were added at a later date. The structure is of wood-frame construction with wood shingle siding, a concrete foundation, and double-hung wood windows. The house has 1-story, shed roof porches on both the south and the east elevations, which date to a later period. The porch on the east elevation is screened and has wood posts. The porch on the south elevation has wood posts and a solid wood railing. In addition, a 1-story addition projects from the north (rear) facade of the structure.

There is one outbuilding associated with this property. It is a garage with a low-pitched gable roof covered with grooved plywood panels. Constructed circa 1970, it is of wood-frame construction and is located south of the main house.

The property is located on the west side of the Old Columbia Pike with residential property to the north and south. The property's setting is secluded, as it is set back from the roadway.


