9. Description
 The 1828 specifications for the dimensions and appearance of the C & O Company Lockhouses produced a 30' by 18' uncoursed rubblestone house, one and a half stories high. There are six over six double hung windows and a large central chimney set into the gable roof. This lockhouse is located on the berm side of Lock 10 facing south.
10. Significance
 The third of the "Seven Locks" of the C & O Canal, the lockhouse is one of the few undamaged by floods. Now restored, it is in good condition and its original hardware has been reproduced and used in restoring other lockhouses.
 The C & O Canal Company obtained the land for the lock in 1830 by condemnation from George Magruder, (heir to a land grant of 1726 to Daniel Magruder and Charles Beall and called "Magruder's and Beall's Honesty"). Cost of building the lock was \$9,729.22 and for the section of the canal around the lock (\$13,839.69). The lock was built of granite from nearby quarries. It is believed that the public quarries at Little Falls provided the stone for the house. The lockhouse was lived in by a succession of lockkeepers until the early 1900's. After restorations by the National Paek Service in 1963, it has been continually occupied.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

In 1828 specifications for the dimensions and appearance of lockhouses were stipulated by the C & O Canal Company. Despite the uniform requirements, each Lock House had its own individuality.

Lockhouse number 10 is located about one hundred feet below Lock 10 on the berm side facing south. It is a one and a half story, uncoursed rubblestone structure, three bays across and one bay deep. The original "masonry" specifications require that the lockhouse be 30' by 18', the cellar walls were to be 22" thick, "principal story" walls, 20" thick, and "attic story" walls, 18" thick. There are six over six double hung windows. These have stone lintels. Two dormer windows with gable roofs are set into the south wall and extend into the roof. The gable roof has asbestos covering. There is a central stone chimney. There is a simple wooden paneled south (front) door with stone lintel. At the east elevation there is a screened porch.

STATEMENT OF SIGNIFICANCE

Lock #10 is the third of the "seven locks" of the C & O Canal, built in the 1830s. Most of the other lockhouses have been damaged or destroyed by floods. But the house at Lock #10 was sited on high ground, and has withstood damage. It has been restored and is in excellent condition at the present time. The original hardware in this house has been reproduced and used in restoring other lockhouses.

Land for this lock was obtained for the C & O Canal Company by condemnation. The Company took the owner, George Magruder, Trustee of George Magruder, deceased, to court, and on November 5, 1830, a jury awarded Magruder \$2,594.78 for 3 pieces of land in perpetuity, an additional \$277 for the 4-year use of 2 other contiguous pieces of land, and \$1 for 63,000 cubic yards of earth used in construction. The company agreed to construct a bridge across Lock #13 to provide Magruder access to his land, and to allow Magruder to pass under culverts of the canal.

Magruder's land was part of a land grant of 1726 acres issued in 1726 to Daniel Magruder and Charles Beall, and called Magruder's and Beall's Honesty.

The contract for the lock was let in 1828 to Kavanaugh, Knox, Hale and Nichols, and abandoned by them in the spring of 1830. The contract was relet to Douglas and Small who finished the project in the fall of that year. Total cost was \$9,729.22. The lock was built with granite from nearby quarries.

The section of canal around the lock was contracted by W.W. Fenlon and Co. and cost \$13,839.69. Fenlon also took over and in 1830 completed construction of the lockhouse, begun by Henry B. Richards in 1828. Later Fenlon worked for the canal as a lock-keeper of Locks 19 and 20. It is believed that the public quarries at Little Falls provided the stone for the house.

Lock #10 was first kept by Thomas Burgess who received a salary of \$150 per year and use of Lockhouse #7 as living quarters; he was assigned to tend Locks #9 and #10. Marshall and J.W. Burriss lived in the lockhouse during the later 1800s. Victor and Virgie Hall, twins, lived in the lockhouse and operated Locks #9 and #10 in the early 1900s. From 1963-1972 Henry Zalinsky occupied the house, following restoration by the National Park Service. Ron Wilson lived there from 1972-1975, and Mr. & Mrs. Sherman Harrington from 1975 to the present.

This is a small, two-story lock keeper's dwelling—built of local rubble stone. The main (south) facade faces the canal, and has a door and window here. The rear (north) wall is blank, but there are dormers on the front and rear. There is a central brick chimney. There are 6/6 windows in both stories in the west-end wall. Lockhouse was restored by the Park Service.

STATEMENT OF SIGNIFICANCE

This was one of the "Seven Locks". It appears to have been occupied for most of its years by the Burriss family. Marshall Burriss was shown there on 1865 map, and a J.W. Burriss was living there in 1894. According to Mrs. Edith Armstrong, Locks 9 & 10 were operated in the 1900's by Victor and Virgie Hall, twins who lived in the lockhouse at Lock #10.


