This Gothic Revival center cross gable house, dating from the mid-1800s, is one of the earliest remaining residences in the Silver Spring area, built between 1852 when Dr. Henry Ford Condict acquired the land, and 1865, when it is shown on a map of the region. The two-story detached dwelling sits on a hillock between the cul-de-sac of Greyrock Road and the cul-de-sac of Harvey Road. Historically the property had a commanding view of Sligo Creek and "the main road leading from Colesville to Washington City," with direct access to what was then known as the Colesville Turnpike. Today the property, consisting of three-quarters of an acre of land, is known as part of Parcel C, Section 7, Woodside Park, and has vehicular access from Greyrock Road and faces Harvey Road.¹

The three-bay front facade faces east toward Colesville Road. Ell-shaped in plan, the frame house is clad with clapboard siding. The main side-gable block has brick end chimneys. A four-bay porch with classical columns, which extends across the full width of the house and wraps around the west elevation. Virtually all of the original 6/6 sash windows in the main block are intact with the exception of a second story picture window on the west elevation, which probably dates from the early to mid-1900s.

Significant architectural details include pointed triangular arch windows with an unusual double-hung sash under a deep cornice in the front and side gables, and a fanlight above the entrance door on the east (front) elevation.

There is a two-story rear ell, and between the rear ell and the main block is a two-story flat roof section. The wrap-around porch was probably built in the late 1800s or early 1900s, and definitely by 1927 when it is shown on a Sanborn map. This porch likely replaced a full-width porch more typical of the Gothic Revival center cross gable building type. A small outbuilding with clapboard siding and a pyramidal hip roof covered with wood shingles was constructed by 1931, when it is shown on a Klinge map. It is located near the driveway entrance from Greyrock Road.

The Dr. Condict House, known in the early 20th century as Grey Rocks (c.1852-1865,) is historically significant as the home of a distinguished family that settled in Montgomery County during the agricultural-transitional period prior to the Civil War. The Dr. Condict House itself is architecturally significant as a vernacular Gothic Revival center cross gable residence, once very common in mid 19th century Montgomery County, but with few examples left in the down-county.

Dr. Henry Ford Condict, his wife, Jane Adelaide Causin Condict, and their two children, Eliza Stone and Causin, moved from Washington, D.C. to Montgomery County c.1852, when Dr. Condict acquired 57 acres of land "near Sligo."² This tract was part of a large land grant called Labyrinth, patented in 1732. Dr. Condict and his heirs lived on this property for some 50 years. Jane Adelaide Condict died before 1880. In 1887 Dr. Condict deeded 28-1/2 acres to his daughter, Eliza, and her husband, Jeremiah Wilbur, who built a residence on the southern half of the original tract that year [now known as the (Barnes)-Wilbur House, 1102 Edgevale Road, Site #36/10].³ The remaining 28-1/2 acres, including Dr. Condict's house, were deeded to Dr. Condict's son, Causin. Dr. Condict died in 1893 "at the residence of his son-in-law, Capt. Wilbur, Sligo, at the advanced age of nearly ninety years."⁴

The Dr. Condict House itself is architecturally significant as a vernacular Gothic Revival center cross gable residence from an early transitional period in the County's history. It is one of the earliest remaining residences in this area of Silver Spring and is very well preserved. The house was built on 57 acres in a choice hilltop location overlooking Sligo Creek and the Colesville Turnpike. While relatively simple in style, the house exhibits classic Gothic Revival features such as the pointed arch window with an unusual double-hung sash in the front and side cross gables.

Henry Ford Condict was born in Littleton, New Jersey, in 1804. After graduating from Princeton in 1822 and teaching for a time, he received a medical degree from Columbia in 1830 and moved to Washington, D.C., where he practiced medicine with Dr. Nathaniel P. Causin, "one of the most highly respected of Washington physicians." In 1832 he married Jane Adelaide Causin, the only daughter of his partner, Dr. Causin. The couple had two children, Eliza Stone, born in 1840, and Causin, born in 1843.⁵

In 1851, Samuel Wroe, a Montgomery County resident, purchased 57 acres of a tract called Labyrinth from the heirs of Joel Simpson for \$1140. In May, 1852, Wroe sold the 57 acres to Nathaniel P. Causin of the District of Columbia for \$1600, "in trust for the use of Dr.

. Condict," his son-in-law. The deed notes that \$1600 was paid to Causin by Condict.⁶

The 1880 census of Montgomery County lists the residents of the property as Henry Condict, 76, physician, widow[er]; Eliza S. Weaver, 40, his daughter, a widow; Causin Condict, his son, 38, farmer, and Causin's 41-year-old wife.⁷ Dr. Condict died in 1893; as noted earlier his wife died before the 1880 census. An 1894 Hopkins map shows the division of the property into halves: 28-1/2 acres to the north designated as "C. Causin," which included the existing house. The deed related to this transaction notes that the right-of-way from the turnpike [Colesville Road] was to be preserved for use by Henry Condict and his son Causin Condict.⁸ The 28-1/2 acres to the south has the notation "Mrs. E. S. Wilbur." Eliza had married her second husband, Jeremiah Wilbur, in 1883 at Grace Church, Silver Spring.

Causin Condict and his second wife, Ada, who was described by one source as a dressmaker, "well educated" and "full of fun," continued to live in the homestead.⁹ In 1889 they acquired an additional piece of property consisting of 47 square perches from Woodbury Blair, Montgomery Blair, Gist Blair, et al., "part of a tract called Falkland Manor."¹⁰ By 1891 Causin and Ada apparently had financial problems and mortgaged the property (the 28-1/2 acres and the 47 square perches) to James W. Clagett (for \$1650) and to Mary W. M. Clagett (for \$1100). The deed states: "The said two pieces of land being the same land on which Causin Condict and Ada C.[sic] Condict now reside."¹¹

Causin Condict died in 1899 at the age of 57. Ada Condict defaulted on the mortgage and in 1904 the property was sold to Charles L. Bliss for \$2800.¹²

Over the next several decades the property changed hands several times and was gradually reduced in size as a result of expanding development in this part of the County. Early twentieth century owners included Eugene A. and Teresa M. Logan, who sold a 4.5 acre piece to

Morton E. Rose in 1908 and the remaining 23.79 acres *including the house* to Ora G. Moore in 1914. The Moore property was conveyed to Robert B. and Blanche H. Armstrong, who in 1926 conveyed 23.79 acres to George R. and Agnes Shields. The 1931 Klinge map reflects the extension of Greyrock Drive from Colesville Road into the Shields property to the north side of the house; the house is identified as "Gray Rocks," the first known use of this name. The 1941 Klinge map spells the name "Grey Rocks," and the extension of Greyrock Drive to the property is no longer shown.¹³

The Shieldses conveyed 8.443 acres of their property to the Maryland-National Capital Park and Planning Commission in 1934 as part of Sligo Creek Park. The Shields family conveyed the remaining 12.597 acres to James A. and Mildred F. Watson and Harold F. and Sarah K. Watson in 1947, and held the deed of trust for \$45,388. In June of 1949 the senior Watsons conveyed half interest in this property to their son and daughter-in-law, Harold and Sarah Keys Watson.¹⁴

The house at 9315 Greyrock Road, sitting on a 0.74-acre site, was sold in August 1949, by Harold and Sarah Watson to David Scull and Elizabeth Lee Scull. David Scull served on the Montgomery County Council during the 1960s. Elizabeth Scull was elected to the Council in 1970 and again in 1974. Their son David L. Scull was elected to the Maryland House of Delegates in 1974. In 1986, as the trustee of his parents' estate, David L. Scull sold the property to its present owners, John R. Mulligan and Ann C. Scheiner, for \$249,500.¹⁵

When the original owner of the house and its 57-acre tract died in 1893, the *Montgomery County Sentinel* referred to him as

[t]he venerable Dr. Henry Ford Condict, who during many years, was a successful practitioner in Washington, settled later in this county, where he made many friends, who regret the affliction caused by his death to the members of his family. His daughter, who is the wife of Capt. Wilbur, has been unceasing in her devotion to him during the many months of his paralysis.¹⁶

In addition to his skills as a physician, Dr. Condict was acclaimed as a classical scholar, in particular for his translation of Thucydides' *The Plague of Athens*.

Today the Dr. Condict House, with its setting of almost three-quarters of an acre, remains a secluded but commanding presence in a neighborhood of smaller lots with houses in a variety of styles typical of suburban development over the last forty years. It is a visual oasis--a well-preserved and pleasing reminder of the transition of this part of the down-County from an agrarian to a suburban environment.

Causin Condict and his second wife, Ada, who was described by one source as a dressmaker, "well educated" and "full of fun," continued to live in the homestead.¹⁰ In 1889 they acquired an additional piece of property consisting of 47 square perches from Woodbury Blair, Montgomery Blair, Gist Blair, et al., "part of a tract called Falkland Manor."¹¹ By 1891, Causin and Ada apparently had financial problems and mortgaged the property (the 28-1/2 acres and the 47 square perches) to James W. Clagett (for \$1650) and to Mary W. M. Clagett (for \$1100). The deed states: "The said two pieces of land being the same land on which Causin Condict and Ada C.[sic] Condict now reside."¹²

Causin Condict died in 1899 at the age of 57. Ada Condict defaulted on the mortgage and in 1904 the property was sold to Charles L. Bliss for \$2800.¹³

Over the next several decades the property changed hands several times and was gradually reduced in size as a result of expanding development in this part of the County. Early twentieth century owners included Eugene A. and Teresa M. Logan, who sold a 4.5-acre piece to Morton E. Rose in 1908 and the remaining 23.79 acres to Ora G. Moore in 1914. The Moore property was conveyed to Robert B. and Blanche H. Armstrong, who, in 1926, conveyed the same 23.79 acres to George R. and Agnes Shields. The 1931 Klinge map reflects the extension of Greyrock Drive from Colesville Road into the Shields property to the north side of the house; the house is identified as "Gray Rocks," the first known use of this name. The 1941 Klinge map spells the name "Grey Rocks," and the extension of Greyrock Drive to the property is no longer shown.¹⁴

In 1934, the Shields' conveyed 8.443 acres of their property to the Maryland-National Capital Park and Planning Commission as part of Sligo Creek Park. In 1947, the Shields family conveyed the remaining 12.597 acres to James A. and Mildred F. Watson and Harold F. and Sarah K. Watson and held the deed of trust for \$45,388. In June of 1949 the senior Watsons conveyed half interest in this property to their son and daughter-in-law, Harold and Sarah Keys Watson.¹⁵

In August of 1949, the house at 9315 Greyrock Road, sitting on a 0.74-acre site, was sold by Harold and Sarah Watson to David Scull and Elizabeth Lee Scull. David Scull served on the Montgomery County Council during the 1960s. Elizabeth Scull was elected to the Council in 1970 and again in 1974. Their son David L. Scull was elected to the Maryland House of Delegates in 1974. In 1986, as the trustee of his parents' estate, David L. Scull sold the property to its present owners, John R. Mulligan and Ann C. Scheiner.¹⁶

When the original owner of the house and its 57-acre tract died in 1893, the *Montgomery County Sentinel* referred to him as

[t]he venerable Dr. Henry Ford Condict, who during many years, was a successful practitioner in Washington, settled later in this county, where he made many friends, who regret the affliction caused by his death to the members of his family. His daughter, who is the wife of Capt. Wilbur, has been unceasing in her devotion to him during the many months of his paralysis.¹⁷

In addition to his skills as a physician, Dr. Condict was acclaimed as a classical scholar, in particular for his translation of Thucydides' *The Plague of Athens*.

Today the Dr. Condict House, with its setting of almost three-quarters of an acre, remains a secluded but commanding presence in a neighborhood of smaller lots with houses in a variety of styles typical of suburban development over the last forty years. It is a visual oasis--a well-preserved and pleasing reminder of the transition of this part of the down-County from an agrarian to a suburban environment.




