DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE						
<p>St. John's Chapel of St. Michael's Parish is a granite Gothic Revival ruin standing on the north bank of the Miles River. The deteriorating walls are partially obscured by ivy. It is in danger of being demolished by the proposed widening of the Miles River Bridge.</p> <p>Similar to other early Gothic Revival chapels built during the second quarter of the nineteenth century, St. John's is basically a rectangular box with a west tower. It is almost identical to the Episcopal Church at Newark, Delaware, except that the Delaware church is covered with stucco and painted white. This type of church is similar to some New England meeting houses, but here the New England steeples are replaced by a crenelated tower. The windows are pointed and have Gothic sashes.</p> <p>The building measures thirty-five feet wide and fifty feet deep, not including the square crenelated tower protruding from the west facade. There are the remains of a chancel and sacristy on the east end.</p> <p>The windows and doors have lancet arches composed of four pieces of dressed granite. Two plaster panels of the same size and shape as the side windows flank the entrance tower. Above the double doors in the tower is a huge lancet opening, formerly a window, but now filled in with boards. Below the top of the tower and above the aforementioned arch is a short arcade, now entwined with ivy. At each corner of the structure is a square buttress which extends above the former "A" roof.</p> <p>The chapel having been abandoned around 1895 and allowed to deteriorate, few pews, sashes, blinds, etc. have survived. Nevertheless, enough detail remains to effect accurate restoration drawings of the vestibule and nave.</p> <p>There was originally a wide block of box pews in the center of the church and a narrow tier of pews along each outside wall. The design of the box pews is similar to the earlier Georgian churches of the area, but with lighter detail. In the two west corners were winding staircases leading to the gallery and tower. Traces of plaster cornice remain on the north side of the tower. The plaster was furred out from the granite walls except on the huge brick arch between the chancel and nave.</p> <p>The Maryland Historical Trust has recommended the ruin to the State Highway Administration and the Historical Society of Talbot County as historically and architecturally important and worthy of preservation.</p>

STATEMENT OF SIGNIFICANCE

St. John's Chapel of St. Michael's Parish was the first Gothic Revival granite church constructed in Talbot County, as well as the first on the Eastern Shore. It has survived to date (1972) as a ruin.

Construction was begun in 1835 on land donated by Charles Lowndes. The Chapel was consecrated in 1839 by the Right Reverend George Washington Doane, Episcopal Bishop of the Diocese of New Jersey (1832). The rector of the parish during the years of construction was the Reverend Joseph Spencer.

St. John's Chapel is apparently the prototype of the granite Gothic Revival church of which there are several in Talbot County, such as Christ Church, St. Peter's Parish (1841); Christ Church, St. Michael's Parish (1878); Trinity Church, Oxford; and the Cathedral in Easton.

The members of the parish during the years of planning and construction were some of the most important and influential people in the state and in the county. Being abreast of the styles of the day, it was logical that they should be responsible for the introduction of the Gothic element into Ecclesiastical building on the Eastern Shore. They constructed a building, which, even in its decay, is a monument to the integrity of taste not only of the Lowndes, Lloyds, Tilghmans, Buchannans, and Goldsboroughs, but also to the workmen who constructed the building and to the black people who were baptized and married there.

Consideration is presently (1972) being given to the stabilization of the walls and possible preservation as a ruin.




