 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Pipe Creek Friends Meeting House is located on Quaker Hill Road, approximately one-half mile from Main Street, via Locust Street, Union Bridge, Maryland.

The Meeting House is a one and one-half story brick structure in Flemish bond on a stone foundation. It is three bays wide and three bays deep with a full length porch across two adjoining sides. The once-shingled roof is now tin-covered and there is an interior chimney at one gable end.

The plain style of the structure reflects the conservatism of the Quaker sect. The only decorative work is the segmental arch of headers over the doors and windows. The windows have rough wood slat shutters, either casement or double hinged. The doors are also fabricated of rough wood slats battened together. The porch presently has a shed roof extending from the wall and supported by square posts with slightly chamfered corners. The gable ends are clapboard from the roofline and on one end there is a hinged door in the gable.

A simplified treatment of facades exists with the east and west facades containing a central door with flanking windows; the north facade has a central window with flanking doors; and the south facade has three bays containing windows. Visual activity is provided in the facades by height differences in the openings in the bays--the opening in the central facade on the north, east, and west sides, and on the south facade the central member is higher than the openings in its flanking bays.

The interior was reconstructed in 1934 due to a fire in October of that year.

A picture taken in the late 1800's shows the original roofline and a woodshed at the southwest corner of the Meeting House. On the east side, the shingled roof flares at the point where the brick wall connects with the roof, forming a slight curve which serves as the porch roof. This porch roof continues around the south gable end and extends over the woodshed. The effect of this sweeping roofline is characteristically rural, similar to the tobacco barns in Southern Maryland, and is visually appropriate to the architectural design and country setting of the Meeting House.

STATEMENT OF SIGNIFICANCE

Pipe Creek Friends Meeting House stands in the area of the oldest land grants in Carroll County. In 1731, the patent "Kilfadda" was made to John Tredane, who sold the land to Allen Farquar in 1734. This passed to his son, William Farquar, who in 1772 deeded two acres from the adjoining "Resurvey on Forrest in Need" to the Society of Friends of which he was a member. This branch of the Friends had established themselves in this region circa 1735, an outgrowth of the "Cold Spring Meeting of the Monoquesey" which had been founded sometime before 1730.

The Pipe Creek Friends Meeting included among its members many of the early and prominent families of the surrounding communities. William Farquar was known for his peace-making ability with the Indians. The Friends concern for the community and its future is shown by their early efforts to establish and maintain a school. The school was begun in 1774 and served as the main educational facility for the children since there was no public supported system. Among the students of this school was the American Sculptor William Rinehart. Another nationally prominent figure associated with the Pipe Creek Friends Meeting is Herbert Hoover, whose great-great-grandfather was a member.

The Meeting House was begun in 1771 and completed the next year. Its plain style architecture is indigenous to the religious concepts of the Quakers and also fulfills the functional requirements of the structure. Originally, the interior had vertical sliding doors in the center to separate the women's and men's meetings and yet be able to open the room up when meeting together. A fire in October 1934 destroyed the interior, but the original benches were saved. The exterior features, particularly the original roofline, are a fine example of the mid-Atlantic folk style.

Records of the minutes of the monthly meetings of the Pipe Creek Friends Meeting are almost complete. They are stored in the Friends Historical Library, Swarthmore, Pennsylvania. Microfilm copies are in the Hall of Records, Annapolis, Maryland.

PIPE CREEK QUAKERS:

This outline history is concerned with Pipe Creek Settlement, - but the movement west by Quakers had been initiated as early as 1726 by a few families who were attracted to the well-watered area with good soil, where the Monocacy meets with the Potomac. Information about this area soon reached others in S. E. Pennsylvania and Allan Farquhar acquired about 200 A., in the area now known as Union Bridge about 1730. He gave this land to his son William and his wife Ann. Other Quaker families soon followed.

Following the death of William in the 1770's, Ann wrote in part, as follows: "He was born in Northern Ireland of Scottish heritage in 1705 and came to America about the 16th year of his age and settled in Pennsylvania. In 1735 he removed and settled at Pipe Creek when there were few inhabitants in those parts."

The earliest religious gatherings were held in the home of the Farquhars'. Following the French & Indian War a log meetinghouse was built north of Little Pipe Creek - the exact location is not known. The present meetinghouse was built in 1771. The first meeting for worship taking place in January 1772. The site of two acres was donated by William P. Farquhar, a son of the first settler. The original deed for the property is in the Friends' Library at Swarthmore College.

William and Ann had a family of six sons and three daughters. Following the Revolutionary War many of the grandchildren migrated to the Northwest Territory, soon to be known as Ohio. One daughter, Susanna, married Solomon Shepherd. They built during the 1790's, the dwelling known as "Hard Lodging"-when it was built it was referred to by the neighbors as "Solomon's Folly" because it is built on a huge rock and also because the house was considered to be pretentious for the period.

The Friends' School, the location of which is unknown at present, opened about the same time the meetinghouse was built. The master of the school, Joel Wright, was a well-educated man as evidenced by his surveying records. He had married Elizabeth Farquhar, another daughter of William and Ann. He remained with Friends' School until the first years of the 19th century when he retired and moved to Baltimore. The noted sculptor, William Rhinehart, was a pupil in the school for a time.

The events of the 19th century caused many Quakers to search for new places to live where slavery did not exist. The Friends' Meeting dwindled in numbers as the century wore on and up to the present day, when we have just 18 members.

The interior of the meetinghouse was destroyed by fire in 1934. Rebuilding took place the following year using lumber from the adjoining woodlot. The exterior brick wall and some of the original benches are what remains of the oldest religious edifice in continuous use in the Maryland Piedmont region.

The Pipe Creek Meetinghouse, situate in an aesthetically appealing environ, is a slightly rectangular block of 1 storey with an "A" frame roof.

at the East end elevation are three bays, viz: w. d. w. The door possesses a shallow segmental arch and the windows are shuttered - at the attic level which is clapboarded is an off center window. All 1st level openings are shuttered by a plain shed roofed porch.

To the N. wall, 1st level, are three bays, viz: two doors with a large window between. This is also true of the S. wall.

at the rear (W) wall are two windows with a door between ~~them~~.

An cemetery protected by a stone wall contains many interesting stones one of which, apparently the oldest, bears the date 1763.

→ Porch runs from the SE corner to the NW. protecting both the E end and N wall.

Eaves boxed - shallow at the side walls but becoming deeper at the gables. The brick is laid in a Flemish bond and is an appealing salmon colour.


