DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE							
<p>The house was built about 1822 by William Linthicum. Originally it consisted of a one-and-one-half story frame part and a three-story field stone portion linked together by an open (south) porch. As William's family increased he added another story to the frame portion, making it two-and-one-half stories high. At that time, he also added a one story front (south) porch, built of neo-classic design with simple Doric columns and ornamented cornices. Eventually the open porch between the frame and stone parts was enclosed.</p> <p>In 1910 Seth Hance Linthicum had the interior of the house remodeled, getting rid of the old kitchen fireplace, but retaining the crane and kettle in the new fireplace. He had the stone part remodelled so that it had only two floors and a crawl space, and removed the winding stairs. In 1920 a two story porch with huge columns, fitting to the decorum of the house, was added to the east end. This consisted of a screened-in porch on the first floor and a sleeping porch on the second. Later changes included enclosing the back (north) porch and addition of a small room, which was the laboratory and storeroom when the present owner, Dr. C. Milton Linthicum, had his medical office there.</p> <p>(Dec. 1949-May 1958)</p> <p>Wooden mantles over the fireplaces in the parlor (west end, first flr.) and master bedroom (middle room, second floor) still remain. They are simple, but gracious. The stairway in the frame portion with its curved balustrade and landings are still present. A beautiful white Italian marble mantel is in the living room; it replaced the old mantel which was destroyed by fire. Some of the original doors with antique hardware are scattered throughout the house.</p> <p>South of the house is a seven story birdhouse built by William Linthicum, which was modelled after Camden Station in Baltimore, Md., as it looked about 100 years ago. West of the house is a carriage house, built about 1880. A portion of it is now converted into a garage. Ice was put in the brick and stone basement and stored until summer. North of the house is a fieldstone "meat" house, built in 1880 (cornerstone is present). A garage was added to the north side in the 1920's. Four large locust trees in the front (south) yard are still standing; they were supposedly planted by William Linthicum's father-in-law, Seth Sweetser, when the house was built.</p>

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

The house is an example of an early nineteenth century house that has been lived in constantly by one family. It shows the changes which have occurred over the generations, but still retains much of its external appearance of a by-gone era.

The builder and first owner, William Linthicum, was an excellent carpenter who also built the Sweetser Toll Bridge over the Patapsco River (Old Annapolis Road now runs over that site). He was also one of the original members of the Holly Run Church, the first Methodist Protestant Church built in the world. His obituary, in 1866, described him as an upright man who could well have represented his area in Congress.

The second owner, Sweetser Linthicum, was a successful farmer. The third owner, Seth Hance Linthicum, was a lawyer and real estate man. He and his three brothers, John Charles, George Milton, and Wade Hampton, developed the town of Linthicum Heights. They not only built houses, but worked diligently to provide stores, schools and a church for the area. Mr. Seth H. Linthicum was the first postmaster of Linthicum Heights and--although quite informal--his home served as the first postoffice. One brother, John Charles, born in the house, was a member of the United States House of Representatives from 1911 to 1932. He was instrumental in having "The Star Spangled Banner" adopted as the National Anthem. Another brother, also born in the house, Dr. George Milton Linthicum, was a prominent surgeon in Baltimore. He taught in some of the local medical schools and was president of the Medical and Chirurgical Faculty of Maryland.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

According to the worksheet prepared for this house in 1969 by Milton Linthicum, it was begun in 1822 by William Linthicum. William's name appears on the 1860 county map for a building in this location. The name of his son, Sweetzer, appears on the 1878 map in the same location. Sweetzer is noted in the list of patrons of the atlas as a farmer, owner of 445 acres. A date stone in the foundation of the carriage house marked "1880", and another stone in the corner of the meat house marked; "S. Linthicum Oct. 1881" indicate that Sweetzer was responsible for the addition of these two structures to the property. Renovations and additions were made to the house itself in 1910. The Palladian porch at the east end of the east section was added in 1920.

The house, as it is today, has three principal parts, attached end-to-end from east to west. The west section is the largest. It is frame construction, five bays long, 2½ stories high, with an A-roof. It is one room deep and has a single, inside chimney at either end. The windows, including those in the three gabled dormers on either side of the roof, all have 6/6 pane sashes. The house stands on a fieldstone foundation and the exterior walls, including those of the numerous rear additions, are sheathed in beaded wood siding of a relatively narrow width. The windows all have louvered shutters. The roof and the dormers have been re-surfaced with slate and a concealed gutter has been installed.

The front entrance, on the north side of the house, is in the center bay. It is framed by narrow top and side lights. An elaborately detailed, flat-roofed porch covers the center three bays of the first floor. The porch has four Doric columns supporting an entablature which features a Doric frieze, dentilled cornice, and, in the architrave, a continuous band of modified guttae. The ends and side sections of the front porch have a simple railing with benches. According to the present owner, this porch was added by William Linthicum several years after the house was built.

The east section of the house is built of stone. It is two stories high, one room deep, and has a chimney at its east end. The interior of this section has been completely remodeled and some of the window openings have been enlarged. The windows all have flat arches made of rubbed brick.

The two story Palladian porch added to the east end of the stone section is the most prominent feature of the house. Both levels are glass-enclosed. The arch over the center bay has a Gothic sash. The railing at the second floor level is reminiscent of the Chinoiserie of the century before.

The hyphen between the east and west sections is frame, 2 stories, with a low roof. It is believed to have been enclosed in the late 19th century. Since the original winding stair in the stone section of the house was removed in the 1910 remodeling, a new one was constructed in the hyphen.

The stone meat house to the north of the main house is unusually large. It has an A-roof with vented brick gables. There is a slit-vent located near the ground on the west and the north walls.

In addition to the carriage house there are several small, frame outbuildings: a summer kitchen, a chicken house and a tiny cottage.




