

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE			
<p>The house at Larkin's Hills is located on the south side of Mill Swamp Road; east of Route Maryland 2 and three and a half miles south of the intersection of Route Maryland 2 and Route Maryland 214.</p> <p>Typical of houses of the one-and-a-half story profile built in Tidewater Maryland prior to 1700, Larkin's Hills house has survived unaltered and in good repair.</p> <p>The gambrel roof lines of the three sections of the house run N/S with a gable at the west end of the main block and a gable at the east end of the smaller east section. The main section has a chimney at each of its own north and south ends. Doors in the main section are opposite each other on the east and west elevations, connected by a central hall.</p> <p>Originally the east entrance was the principal entrance, the water side usually being the important eighteenth-century ingress to Tidewater property. The landside entrance was from Mill Swamp Road, northeast. Hence the "showcase" brickwork appears as all-header bond on the east and north walls; the west and south walls are English bond. The east and north walls comprise an early example of all-header bond in the county.</p> <p>The three windows and one door, on each elevation of the first floor of the main section, have arched lintels of alternating single, glazed and rubbed brick headers, an exceptional feature. The windows are double-hung, nine over nine sash at the first floor; six over six in the shed dormers in the roof.</p> <p>The main house plan remains the same, consisting of four first floor rooms and the stairhall; two bedrooms above.</p> <p>A sunporch was added, to the south, in 1920 and in 1951 an identical north end wing was added. The latter wing houses a dining room and kitchen on the first floor; two bedrooms above.</p> <p>In the main section raised panelling appears in the central hall, over and around the parlor fireplaces and as the soffit, or underside, of the staircase and is all of early design. The three first floor fireplaces are on the diagonal in the inside corners of each room. Two of the hearths are laid with hexagonal bricks. A fourth fireplace is closed and conceals the modern furnace piping, using the flue. There are two more fireplaces on the second floor. Four flues are known to run into one chimney stack.</p>

## STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

A State Roads Commission marker erected on January 4, 1939, reads:

PATENTED 1663

"CHARLES, LORD BALTIMORE AND HIS COUNCIL ATTENDED THE MEETING OF THE ASSEMBLY HERE OCTOBER 2 - NOVEMBER 6, 1683. 31 TOWNS AND PORTS OF ENTRY WERE ESTABLISHED AT THIS SESSION IN THE SEVERAL COUNTIES ALONG THE BAY. PRACTICALLY NONE OF THESE TOWNS EXIST AT THE PRESENT TIME."

Six hundred and fifty acres of land on the Ridge surveyed in 1661 were patented, in 1663, to John Larkin, one of the early Quakers of Anne Arundel County.

Larkin built his house, which still stands, before the 1683 meeting of Charles, third Lord Baltimore, with the General Assembly of Maryland on October 2, 1683.

Larkin later operated an inn here, taking advantage of his location on the Severn Ridge Road, once an Indian trail, now the "Solomon's Island Road" (Route Maryland 2), running south through the center of lower Anne Arundel County.

The first regular postal route in Maryland from St. Mary's and through Annapolis included a stop at Larkin's Inn. Larkin's Hills served as a temporary capital of Maryland in 1683.

"...the older wing of the present gambrel-roofed house was the site of the first capital of the Province...was used for council meetings between 1692 and 1694...."

One of the several frame outbuildings, all of which have disappeared, was a very early courthouse. Governor Sir Lionel Copley and his Council met there in 1692; Colonel Nicholas Greenbury and his Council met there in 1694.

#8. SIGNIFICANCE

Colonel Nicholas Greenbury, member of a powerful political faction in early Maryland, was in 1691 appointed one of the judges of the Provincial Court. He was a member of the Governor's Council under Sir Lionel Copley and upon Copley's death, in 1693, served as Acting Governor until superceded by Sir Edwin Andres.

In the twentieth century this farm commands reknown as one of Maryland's best known thoroughbred horse-breeding and training farms.

Larkin's Hill Farm and its environmental import will be a candidate for the forthcoming statewide historic preservation plan to be submitted to the Department of Interior in 1971.

Six hundred and fifty acres of land were patented in 1663 to John Larkin, one of Anne Arundel County's early Quakers. Larkin built his one and a half, gambrel-roofed brick house before 1683 and it survives unaltered to this day.

Located at Millswamp Road and Route 2, Larkin's Hills exhibits the earliest known example of all-header bond in Anne Arundel County. Inside the house, raised paneling appears in the center hall, around the fireplaces and under the staircase and is of very early design. First floor fireplaces are on the diagonal on the inside corners of the rooms. Two hearths are laid with hexagonal bricks. This interior plan is believed to have been influenced by the Swedes who settled in Delaware during the mid-Seventeenth Century.

Using his location on the old Severn Ridge Road, (once an Indian trail, later the Solomon's Island Road) now Route 2, Larkin opened an inn. The first postal route in Maryland, from St. Mary's through Annapolis, included a stop here. Larkin's Hills also served as temporary capital of Maryland in 1683. One of several outbuildings, all long gone, was an early courthouse. Governor Sir Lionel Copley and his Council met here in 1692; Colonel Nicholas Greenbury and his Council, in 1694.

Today, Larkin's Hills commands renown as one of Maryland's finest thoroughbred breeding and training farms.

Larkin's Hills and its environmental import will be a candidate for the forthcoming statewide historic preservation plan to be submitted to the Department of Interior in 1971.
