
The house is a one-and a half story gable and wing building with multiple additions. The large center gable is covered in aluminum siding, while the ground floor is sheathed in formstone. The windows are one over one in the gable, and appear to be louvered in the main room of the house. The building is four bays long, excluding the garage addition. The garage is a side gable addition which is one bay long but two stories high, allowing a car to drive under the house. The double sliding window appears to be a replacement. The roof is covered with asphalt shingles.

The property has no known associations with events or persons important to national, state or local history, and thus is not eligible under National Register Criteria A or B. The house is characteristic of the rural dwellings built in the late 1930s and early 1940s, but it lacks significant architectural elements, as well as integrity of materials and form, and thus is not eligible under Criterion C of the National Register of Historic Places. Criterion D was not examined as part of this study.

# Prince George's Co. Tax Map 9, Parcel 126




