Description:

The Virginia Peed Property is a 1-story, 3-bay front-gable cottage on the north side of Contee Road in the Laurel vicinity of Prince George's County. Constructed circa 1930, the building has a full-width porch on the front elevation and a 3/4-width hipped roof addition on the rear elevation.

The structure has an asphalt shingle, front-gable roof with an interior brick chimney. It is of wood-frame construction with vinyl siding, and it has a rock-faced concrete block foundation. The windows are 1/1 double-hung wood; the hipped-roof addition has jalousie windows. The front entry is a centrally located wood door with 12-lights. The front porch has an asphalt shingle, hipped-roof supported by round, tapered wood columns and a wood floor. The hipped-roof addition is supported by concrete block piers. The addition has a wood door on the east elevation, accessed by wood steps.



There are four outbuildings associated with the property. The first outbuilding is an asphalt shingle, front-gable garage. Constructed circa 1930, it is of wood-frame construction. The garage is located east of the cottage.

The second outbuilding is a small shed with an asphalt shingle, gable roof. Constructed circa 1930, it is of wood-frame construction. The shed is located north of the cottage and northwest of the garage.

The third outbuilding is a shed with an asphalt shingle, shed-roof. Constructed circa 1930, it is of wood-frame construction. The shed is located northwest of the cottage, garage, and small shed.


The fourth outbuilding is a prefabricated, steel shed constructed circa 1975. The steel shed is located northwest of the cottage, garage, and small shed, and south of the shed-roof shed.

The property is located on the north side of Contee Road, with a residence to the east and a mosque to the west. There are woods to the north. The site slopes down to the northeast from Contee Road, and there are mature trees near the house. The property's setting is a rural area along a road which has become a major traffic route.


