Description:

The Thompson House is a 1-story, 3-bay cottage with bungalow features on the north side of Muirkirk Road in the Beltsville vicinity, Prince George's County. The cottage was constructed circa 1920.

The structure has a side gable, asphalt shingle roof with a small shed dormer and centered brick chimney. It is of wood frame construction with vinyl siding, and it has a clay tile foundation. The windows are double-hung, aluminum sash. The house has a shed roof porch on the south elevation. The porch has a concrete masonry foundation, wood posts and railings, vinyl soffit and asphalt shingle roof.

There is one outbuilding associated with this building. The outbuilding is a shed with a gable roof covered with asphalt shingles. Constructed circa 1930, it is of wood frame construction. The structure is located north of the house.


