Description:

The Charles Hurley Property is a 1½-story, 3-bay side-gable cottage on the west side of Old Gunpowder Road in the Calverton area, Prince George's County. Constructed in 1947, the cottage has a garage addition on the north elevation and a large rear shed-roof addition with an integrated porch.

The structure has an asphalt shingle, side-gable roof with two gable dormers on the rear elevation. There is an exterior concrete block chimney on the north elevation, and a metal chimney pipe secured to the exterior wall, adjacent to the chimney. The house is of concrete block construction with formstone siding, and it has a concrete block foundation. The windows are 1/1 double-hung aluminum; the front elevation has a picture window with flanking double-hung windows. The rear addition has paired aluminum casement windows. The front entry is a wood door with a small entry porch.

There are two outbuildings associated with this property. The first outbuilding is a kennel, with an asphalt shingle, gable roof. Constructed circa 1980, it is of wood-frame construction. The structure is located west of the house.


The second outbuilding is a shed with an asphalt shingle, gable roof. Constructed circa 1980, it is of wood-frame construction. The structure is located west of the house and kennel.

The property is located on the west side of Old Gunpowder Road with a church to the north, a residence to the south, and the church parking lot to the west. The site slopes up to the southwest, and there are several mature trees on the property. The property's setting is a rural area along a road which has become a major traffic route.


