Description

The McCarthy-Singleton House is a one-and-one-half story gable roof frame dwelling of irregular plan, situated on a large town lot. The house has grown through a series of additions, which have been adapted to the slope of its setting. It overlooks Hollywood Road, to its north. The north (main) facade contains the original one story, three-by-two bay gable roof cottage, covered with horizontal tin or aluminum siding, painted white. An exterior corbelled brick chimney is centered on its west gable end. A one story shed roof sunroom with a band of casement windows was added to the east gable end. To the south (rear) of the original structure was added a large one-and-one-half story three-by-two bay gable roof wing with lunette windows in its north and south-gable ends. Its east and west facades have three gable roof dormers with casement windows. The wing is covered with horizontal wood siding, rests on a brick foundation has an asphalt shingle roof and a boxed wood cornice. The corners are marked by narrow pilaster corner boards. The south (rear) gable end has a one bay gable roof rear porch. There is a gable roof, frame garage to the west of the house and two large old elm trees.

The McCarthy-Singleton House is a cottage-style dwelling that has evolved in size and use since the original structure was built in the 1930's. The one-story building was built as a summer cottage by Gladys and Frank McCarthy in 1937. The McCarthys acquired more property in 1957, and added to the building for use as a permanent dwelling. Col. Frank McCarthy was a U.S. Army architect. He designed the structure and its additions. The cottage-like style of the structure has been maintained. The additions were adapted to the slope of the lot. The two-story, three-bay addition is set lower and to the rear of the small original block. The contrast in height and size is de-emphasized. The gable roof and casement windows of the original are repeated in the additions. Overhanging eaves and horizontal bands of windows create a one-story appearance. Additions to the building since 1982 include the one-bay enclosed portico on the main facade, and a two-story addition extending the larger, newer wing one-bay to the south (rear).

The McCarthy-Singleton House is a one-and-one-half story gable roof frame dwelling of irregular plan. It is situated on a large town lot which slopes to the west. The house has grown through a series of additions, which have been adapted to the slope of its setting. It overlooks Hollywood Road, to its immediate north.

The north (main) facade contains the original one story, three-by-two bay gable roof cottage. It is covered with horizontal tin or aluminum siding, painted white. An exterior corbelled brick chimney with corbelled weathering is centered on its west gable end. A one story shed roof sunroom with a band of six light casement windows was added to the east gable end of the original structure.

To the south (rear) of the original structure was added a large one-and-one-half story three-by-two bay gable roof wing, twice the size of the original structure. The wing has lunette windows in its north and south-facing gable ends. Its east and west facades have three gable roof dormers with casement windows. The east facade has an interior brick chimney between the second and third bays. The wing is covered with horizontal wood siding and rests on a brick foundation. There is an asphalt shingle roof and a boxed wood cornice with a raking cornice of plain board. The corners are marked by narrow pilaster corner boards. Rafter ends project beneath overhanging eaves on the east and west. The south (rear) two bay gable end has a one bay gable roof rear porch on the second bay. Wooden posts support the porch roof, which has horizontal wood siding covering the pediment.

There is a gable roof, frame garage to the west of the house. Two large old elm trees are directly west of and shade the house.

Prepare both a summary paragraph of significance and a general statement of history and support.

The McCarthy-Singleton House is a cottage-style dwelling that has evolved in size and use since the original three-by-two bay structure was built in the 1930's. The original one-story building was probably built as a summer cottage by Gladys and Frank McCarthy around 1937.¹ The McCarthys acquired more property in the area in 1957,² and added to the building in several stages, for use as a permanent dwelling. Colonel Frank W. McCarthy was an architect in the U.S. Army. It is believed that he was responsible for the design of the structure and its additions.³

Although the size of the interior space has been tripled, the cottage-like style and character of the original structure has been maintained. This has been accomplished in several ways. The additions were adapted to the slope of the lot, giving the house a picturesque quality. The two-story, three-bay addition is set lower and to the rear of the smaller original block so that the contrast in height and size is de-emphasized. The gable roof and casement windows of the original are repeated in the additions. Overhanging eaves and horizontal bands of windows create a low, one-story appearance. Additions to the building since 1982 include the one-story, one-bay enclosed entrance portico on the main facade, and a one-bay, two-story addition extending the larger, newer wing one-bay to the south (rear).


