Description

The Bernabo House is a two-story frame house of the flat-front or "free-standing rowhouse" type. Entrance is in the second bay of the two-bay south facade, which is sheltered by a one-story hip-roof porch with plain posts. The original wood siding is covered with beige asbestos shingle. At the horizontal eaves of the principal facade, the molded cornice and frieze are decorated by jigsaw brackets painted brown, as is the other trim. There are additions at the rear and the west side.

Significance

The Bernabo House is a good example of urban vernacular domestic architecture, of the flat-front, or "free-standing rowhouse" type. It is one of only two surviving examples of this dwelling form from the earliest building period in Brentwood. It is distinguished by its decorative bracketed cornice. It was built in 1902 for the family of Frank Bernabo, who worked as a house painter.


