Description

The Brentwood United Methodist Church is a front-gabled frame structure with a three-story pyramidal-roof bell tower added on its northeast corner. A gabled vestibule shelters the main entrance into the south gable front. The walls are covered with tan stucco. In the three-story corner tower, the windows at first and second level are filled with milky-opaque colored glass, and there are wood louvers in the openings at third level.

Significance

The Brentwood United Methodist Church is a prominent landmark in one of the oldest sections of the community of Brentwood. By 1903, a group of new residents of the Brentwood community were gathering to worship together in a barn near the intersection of Dewey and Wells Streets. Under the leadership of Reverend A.L. Hughes, the group acquired lot 16 in Block 5, at the corner of Wells and Campbell Streets, and construction of a church building began in 1904. This new church building was known as Hughes Chapel, after the first pastor. In 1907, after Reverend Hughes left the area, five men, Robert A. Van Horn, Edward Gemeny, Benjamin F. Barb, Amos W. Hawk, and Frank A. Tyler, incorporated to form the Brentwood Methodist Episcopal Church South, and the former Hughes Chapel became part of the Hyattsville Methodist charge. Just after the First World War, the Brentwood church was enlarged by the construction of a bell tower, and the newly enlarged church was dedicated in 1919. In 1921, the church and its pipe organ were insured against damage by fire. In 1929 the wood siding was covered with stucco, the building was raised and a basement added, and a new entrance vestibule was built over the door on the south facade. Today the handsome building with its prominent tower is a visible landmark in the Brentwood community.


