Description

3837 34th Street is a two story, two-by-three bay frame dwelling with an "L" shaped plan and an asphalt shingle cross gable roof. The exterior of the building is sheathed with asphalt shingle siding and has metal clad 1/1 sash double-hung windows. Most windows have decorative wooden shutters. A hipped roof porch, supported by wooden columns and enclosed by a plain wooden railing, shelters the first story of the main (west) facade and wraps around the west half of the south facade. The two bay main facade has a single wood and glass entry door to the north with molded wooden panels below a large single upper glass light. The main (west) facade terminates in a pedimented, gable-end attic with a metal clad 1/1 sash double-hung window. The exterior of the dwelling has been unsympathetically altered with non-historic materials including asphalt shingle siding, metal clad windows and inappropriate decorative shutters. The building retains many of its early features including plan, wraparound porch, pedimented gable-end attic, entry door and window placement. The nature and condition of underlying historic fabric is not discernible.

Significance

The two story, single-family frame dwelling at 3837 34th Street (Block 1, Lot 27, Rhode Island Avenue Addition to Mt. Rainier) contributes to the character of the survey area as an early 20th century neighborhood. Although it has been sheathed with non-historic materials, the dwelling retains its early character and is similar to a number of dwellings built on the south side of Rhode Island Avenue east of 34th Street in the early decades of the century. Lot 27 was originally sold by Messrs. Bigelow, Spalding and Rogers in September of 1906 to Robert and Minerva Scroggins. The present dwelling is the site's original improvement and was apparently erected by 1907 when assessment records first indicate an improvement valued at \$1,500. The Scroggins retained ownership of the parcel until March 1907 when they sold it to Carl and Anna Rader.

CONTRIBUTING

The two story, single-family frame dwelling at 3837 34th Street (Block 1, Lot 27, Rhode Island Avenue Addition to Mt. Rainier) contributes to the character of the survey area as an early 20th century neighborhood. Although it has been sheathed with non-historic materials, the dwelling retains its early character and is similar to a number of dwellings built on the south side of Rhode Island Avenue east of 34th Street in the early decades of the century.

Lot 27 was originally sold by Messrs. Bigelow, Spalding and Rogers in September of 1906 to Robert and Minerva Scroggins.¹ The present dwelling is the site's original improvement and was apparently erected by 1907 when assessment records first indicate an improvement valued at \$1,500.² The Scroggins retained ownership of the parcel until March 1907 when they sold it to Carl and Anna Rader (see Chain of Title).


