Description

3842-3856 34th Street is a two-story five-by-two-bay brick commercial building with a rectangular plan. The facades are sheathed with brown brick and a crown molded metal cornice conceals a west sloping shed roof. The building contains five storefronts on the east (34th Street) facade and the second story contains apartments. The bays of the east facade are defined by brick pilasters with limestone or concrete bases and capitals. The four southernmost storefronts are equal in size and the northernmost is slightly larger. The four southern storefront have a rectangular plan plate glass show window on a brick base with a transom above. The entrances are recessed at right and contain a single wood and glass door. The storefronts share a molded metal cornice that is interrupted by the facade's brick pilasters. The second story of each bay contains three attached 1/1 sash and centered double-hung windows. Above the second story is a molded metal cornice resting on top of the pilaster capitals. The pilasters extend above the second story cornice and each bay is defined by a recessed brick panel that forms an unadorned entablature.

Significance

The commercial building at 3842-3856 34th Street (Block 7, northeast part of Lot 19, Roger's Second Addition to Mt. Rainier) is significant as a nearly intact example of early 20th century mixed-use construction. The building's main (east) facade is essentially unaltered and the combination of details found in the storefronts and the modulation of the bays with their brick pilasters, contrasting bases and capitals and metal cornices give the commercial block a well-defined and articulate, neo-classically inspired expression. The present building can be dated to 1927 when improvements valued at a total of \$12,500 were first indicated for the northeast portion of Lot 19. The building was erected by Charles M. and Maud E. Lightbown. Ownership of the present building remained within the Lightbown family until 1943 and since then it has had a succession of owners.

3842-3856 34th Street is a two-story five-by-two-bay brick commercial building with a rectangular plan (see Slide #29). The facades are sheathed with brown brick and a crown molded metal cornice conceals a west sloping shed roof. The building contains five storefronts on the east (34th Street) facade and the second story contains apartments. The bays of the east facade are defined by brick pilasters with limestone or concrete bases and capitals. The four southernmost storefronts are equal in size and the northernmost is slightly larger. The four southern storefront have a rectangular plan plate glass show window on a brick base with a transom above. The entrances are recessed at right and contain a single wood and glass door. The northernmost storefront has its entrance at left and a double width show window. The three southernmost bays contain single wood and glass entry doors to the right of the storefront entrances, leading to the upstairs apartments. The storefronts share a molded metal cornice that is interrupted by the facade's brick pilasters. The second story of each bay contains three attached 1/1 sash and centered double-hung windows. Above the second story is a molded metal cornice resting on top of the pilaster capitals. The pilasters extend above the second story cornice and each bay is defined by a recessed brick panel that forms an unadorned entablature. The two-bay north facade is unfenestrated. With the exception of contemporary signage over several of the storefronts and aluminum combination storm and screen windows, the building has maintained a high degree of its architectural integrity and is in very good condition.




