Description:

The Warren house is a two-and-one-half-story, hip and gable-roofed frame house which features a variety of fine details; an oriel window, projecting bays, and pediments decorated with Queen Anne style shingle. Its main facade is to the south, with entrance into the second bay through a door with a single pane transom. In the first bay is a small leaded stained-glass window; the east half of this main south facade is filled with a three-window projecting semi-hexagonal bay. The entire south facade is sheltered by a one-story porch, supported by heavy square posts which form four flattened-arch openings; the westernmost and principal opening is surmounted by a steep pediment filled with raised geometric design. The semi-octagonal bay is repeated in the second story, and is surmounted at third level, by a pediment decorated with fish scale slate shingle; its raking cornice is decorated with dentils. There are two asymmetrical pediments on the east elevation, and on each of the north and west elevations; all are decorated with fish scale shingles and dentilled cornices. In the southernmost bay of the west elevation at second story is a three-window oriel. Three small leaded stained glass windows light the front hall and staircase. The house is shingled with German siding painted white. Most windows have shutters; they are louvered and painted gray. The house rests on a high pebble concrete foundation. The cornice is dentilled throughout, and the roof is of slate shingle.

Significance:

The Warren house is an excellent example of late vernacular Queen Anne architecture with abundant fine detail. It stands on a corner lot in the suburb of Riverdale, just west of the Calvert Mansion. The Town of Riverdale was subdivided in the late 1880's by the Riverdale Park Company on the grounds of the Calvert family estate. Located on the line of the Baltimore and Ohio Railroad just a few miles northeast of Washington, this new community offered suburban living to people who worked in the Capital City. The community included church, school and stores, and promised a healthy environment. The lots (#19 and 20 in Block 46) on which this house stands were sold in 1908 to Carrie Warren, and the house was constructed circa 1913. It incorporated a variety of late Queen Anne styling, with an oriel window, and considerable decorative detail in the asymmetrical pedimented gables. It remained in the possession of the Warren family until 1981; it stands now, in excellent condition, a fine example of its type.

The Warren House is a two-and-one-half story frame house which stands on one of the lots of the town of Riverdale. It is distinguished by a variety of fine decorative details: an oriel window, projecting bays and wrap-around porch, and pedimented gables embellished with novelty slate shingle.

The house is basically square, with asymmetrical gables and bays varying the lines. The main facade is to the south, with entrance in the second bay through a panelled glazed door with single-pane transom. In the first (westmost) bay is a small square window which lights the staircase; it is filled with stained glass, as is the transom. The easterly half of the principal south facade is filled with a two-story hip-roof projecting semi-octagonal bay; on each story the bay is lighted by three 1/1 double hung sash windows. Above the hip roof of the projecting bay, a cross-gable pierces the south plane of the roof at third level. Its gable end is sided with fishscale slate shingle, and lighted by a small 1/1 window; its raking cornices are embellished with dentil moldings.

The entire south facade is sheltered by a one-story hip-roof porch which wraps around and shelters part of the east facade; the porch is supported by heavy square posts which form flattened-arch openings, four on the south facade and three on the east. There is a railing of plain balusters. The westmost principal opening in the porch is surmounted by a steeply pitched pediment; the tympanum is ornamented with applied geometric panelling, identical to that of the Holden-Sweeting House (P.G. #68-10-2). The high porch rests on brick piers infilled with lattice. The principal south door is accessible by a flight of brick steps, which has replaced the original concrete steps.

The house is sheathed with German siding painted white. Windows are generally 1/1 double hung sash, with plain board surrounds and louvered shutters painted dove gray. The boxed, molded cornice has a deep overhang, and is continuously dentilled on all elevations. The hip and gable roof is covered with slate shingle, and there is a brick chimney roughly centered at the ridge. The house rests on a pebble concrete foundation which encloses a full basement.

The wall surfaces are further varied by other details. In the southmost bay at second-story level is a pyramidal-roof oriel window. It is lighted by a 1/1 window in each of its three faces. Unlike the oriel of the Holden-Sweeting House, this oriel has a five-plane roof integral with that of the main block.

There are two asymmetrical cross-gables at third level on the east elevation, and one on each of the north and west elevations; like that on the main south elevation, all are decorated with fish-scale slate shingle and dentilled cornices.

There is a one-story projecting bay in the northmost bay of the east facade; it is lighted by a 20/1 window in its east face, and a 12/1 window in each of the angled faces. A small shed-roof porch forms a rear entrance to the kitchen in the westmost bay of the north facade; it rests on brick piers infilled with lattice and has a plain railing.

There are two small single-pane windows in the west elevation, both filled with stained glass; the southmost of these windows lights the formal staircase, and the northmost (at mid-story level) lights an enclosed rear stairway.

The interior of the house consists of four basic spaces. The main south entrance leads into a square stairhall in the southwest quadrant. The closed-string three-run staircase begins near the southwest corner, framed by two square beaded newel posts with applied molding. The stair turns and rises along the west wall, then turns again to the east; it has rectangular balusters and panelled spandrel. The staircase is lighted at the first landing by a small stained glass window, and at the second landing by a plain 1/1 double hung sash window.

A molded chair-rail adorns the walls of the stairhall. Below the chair-rail, the walls are clad with an unusual and handsome pressed composition covering, decorated with continuous rectangular and floral designs.

A pair of five-panel double doors (which retract into pockets in the wall) leads eastward from the stairhall to the parlor in the southeast space. This parlor is lighted on the east by a tall window and jib door which leads out onto the east porch. A second pair of pocket doors leads from the parlor into the dining room in the northeast space. This room is enlarged and lighted on the east by a one-story projecting bay. A modern brick surround has been built around the fireplace in the west wall of the dining room. Doors and windows throughout have plain board surrounds with classical architrave lintels. All wood trim is natural and unpainted.

The house is situated on a town lot, fronting on Oliver Street at the corner of 48th Street. Directly behind the house to the north is a small hip-roof well-house, which encloses a probably original well, now capped

with concrete. The well-house is sided with lattice above vertical board, and has gray asbestos shingle roof covering. Northwest of the well-house is a hip-roof garage. It is sided with horizontal board and lighted on three sides by a nine-pane single-sash window; its roof is covered with gray asbestos shingle, and the overhanging eaves are punctuated with exposed rafter ends. This garage building is said to have been moved from another location, during the owner, Claude Warren's term as Mayor of Riverdale.

with spindle-work grille; the wood trim of the Warren house featured Classical Revival architrave moldings, which increased in popularity during the first decade of the twentieth century.

Claude Warren was elected Mayor of Riverdale in 1953, and served six two-year terms, ending with his death in December 1964.⁴ The house remained in the possession of his widow and her sisters until 1981.⁵

The Warren House is an excellent example of late Queen Anne transitional suburban cottage. It incorporates a variety of fine decorative detail, with its oriel window and asymmetrical pedimented gables. It is a fine example of its type, and a noticeable landmark in the late Victorian suburb of Riverdale.

The westernmost and principal opening is surmounted by a steep pediment filled with raised geometric (wooden) design. The porch rests on brick piers (with lattice infills), and wraps around approximately half of the east side of the house. The (south) projecting semi-octagonal bay is repeated in the second story, and is surmounted at third level, by a pediment decorated with fish scale slate shingle; its raking cornice is decorated with dentils. There are two asymmetrical pediments on the east elevation, and on each of the north and west elevations; all are decorated with fish scale shingles and dentilled cornices. In the southermost bay of the west elevation at second story is a three-window oriel. Three small leaded stained glass windows light the front hall and staircase.

The house is shingled with German siding painted white. Most windows have shutters; they are louvered and painted dove gray. The house rests on a high pebble concrete foundation. The cornice is dentilled throughout, and the roof is of slate shingle.

The house stands on a small town lot. Directly behind it is a small hip-roofed latticed summer house. A little farther north, at the corner of the lot, is a separate garage structure.

The Warren house is an excellent example of late vernacular Queen Anne architecture with abundant fine detail. It stands on a corner lot in the planned suburb of Riverdale, just west of the focal point of that community, the Calvert Mansion.

The Town of Riverdale was subdivided in the late 1880's by the Riverdale Park Company on the grounds of the Calvert family estate. Located on the line of the Baltimore and Ohio Railroad just a few miles northeast of Washington, this new community offered suburban living to people who worked in the Capital City. The Riverdale Park Company offered a variety of vernacular types of dwelling, from exuberant Queen Anne styling to pyramidal-roofed square simplicity. The community included church, school (donated by the company), and stores, and promised a healthy environment.¹

The lots (#19 and 20 in Block 46) on which this house stands were sold by the Riverdale Park Company in 1897, but the new owner, William Boyd, did not build. In 1908, he sold the lots to Carrie Warren, and the house was constructed circa 1913.² It incorporated a variety of late Queen Anne styling, with an oriel window, and considerable decorative detail in the asymmetrical pedimented gables. It remained in the possession of the Warren family until 1981; it stands now, in excellent condition, and a fine example of its type.


