

There is an office-width awning supported by steel, extending over the two pump islands, one self serve, one full serve. Three pumps on each. Almost full height plate-glass windows with aluminum frames. The three bay doors fold up and backwards into the garage. The bays are still used to repair cars. Glass panels over the bay doors carry the word TEXACO.


