Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

Law offices for Carlton Green constructed about 1930. The two-story limestone over brick building is an envelope around a wood frame house which still exists, largely intact within the present structure. The wooden house was built about 1910. The tip of the gable is visible from the street. The ground slopes up from the rear, and an additional floor is apparent, making the building three stories at the back. The upper floor at the front has five metal framed windows while the street level has one central door with two different style and size windows either side.

In the late 1930's the building was expanded to the north by Green. the extended upper portion was built exactly to match the existing building while the first floor was installed as a beauty salon, and the facing was apparently left exposed brick. The beauty salon is now part of the law office space.
