

Formerly the Local Paint and Hardware Co. the conversion to law office space occurred in the late 1950's. The building was constructed on the site of a wooden house, and was exposed brick with a central door inbetween two exteded showcase windows. Originally rented and run by Bill Riden, it closed when Riden moved to take over Hyattsville Hardware, and Green, who owned the property converted the space for office and storage use.
