A smaller building is shown on the 1933 sanborn map. It had four gas pumps in front of a single office building. Tile is indicated as the exterior covering. After the 1940's the office area was expanded to include the garage bays, probably in two phases. Following use as a gas station and repair shop, the facility was used for the repair, maintenance and parking area for the current cab company.
