This building is two stories tall, made of 6 course common brick bond on three elevations. The south wall is unique because of pilasters. The two bay facade has cast stone blocks and four large show windows surrounded by metal frames. Natural wood siding is applied to the facade just below the window sills. There is a parapet in the facade and side elevations decorated with small bow-tie-like openings at the cornice. The building has a flat roof and located in the northeast corner is a very large capped brick chimney stack.

By referring to the Sanborn Fire Insurance Maps of 1933 and 1939 it can be deduced that this building was constructed sometime during that interval. Built specifically as a food store, the Safeway served Hyattsville and the surrounding area for many years. When a new Safeway was constructed in the late 1970s on Chillum Road in Mt. Rainier, declining patronage forced the Baltimore Boulevard Safeway to close its doors. The Pier One business has not significantly altered the building, an old entranceway or window on the southwest corner has been bricked in and a horizontal backlit plastic sign has been placed on the facade.
