Description

The Orr House is a two-story flat-front frame dwelling with shed roof of very shallow pitch. Entrance is in the first bay of the three-bay east facade, sheltered by a one-story plain porch. The original wood siding is covered with pink and white aluminum siding. All Victorian trim has been removed from the horizontal cornice. Windows (except those sheltered by the front porch) have pink and white striped awnings.

Significance

The Orr House is an important element of the black community of North Brentwood; it is representative of the urban vernacular dwellings, sometimes referred to as "free-standing rowhouses", which were built on the narrow lots of early twentieth-century suburbs. It was built in 1913 for the family of Robert Orr. Although substantially altered by the application of aluminum siding and the removal of Victorian trim, it is still representative of a popular period house type.


