Description:

The H.A. Kelly House is a two-and-one-half-story (ca. 23' x 30') frame gable-roofed cottage which rests on a high brick basement. The principal facade is the north gable end: in the first bay is a three-window semi-octagonal bay, in the second is the main entrance sheltered by a small entry porch. The main door has five-light transom and three-light sidelights. Door and windows have plain board surrounds with shallow pediments. At loft level is a small triangular window. On the three-bay west side of the house, there is a narrow central peaked gable lighted by a five-pane pointed-arched window. A one-story porch with turned posts runs the full length of this west side at first-story level. The north and south gable ends, as well as the central peaked gable on the west, are ornamented with elaborate barge-boards, with running S-shaped swirls; at the apex of each is a tall finial. The original German siding is presently covered with asbestos shingle. There is a large central brick chimney; the roof has recently been covered with synthetic shingle. The interior plan consists of front and back parlors on the east, with fireplaces back-to-back in their common wall; on the west is the stairhall.

Significance:

The H.A. Kelly house is the only one of three Victorian cottages remaining in near-original condition in the town of Seabrook. It may be the only structure of its genre (i.e. a cottage built in a planned rural retreat) in Prince George's County today, and as such it is the prototype for the other two Seabrook cottages, once identical but much altered in recent years. This retreat community was developed by Thomas Seabrook, a Philadelphia engineer for the Pennsylvania Railroad. Three Victorian cottages were constructed before 1888 and used as vacation residences by Thomas Seabrook and his colleagues. The subject house was sold to Henry A. Kelly in 1896 and has been privately owned by only two families since then. Its significance lies in the fact that it is probably unique in Prince George's County, and can serve as a model for restoration of the other two cottages.

The H. A. Kelly house is a two-and-one-half story (ca. 23' x 30') frame gable-roofed cottage which rests on a high brick basement. The principal facade is the north gable end. In its first bay is a three-window semi-octagonal bay; its windows are 4/6. In the second bay is the principal entrance; the door has five-light transom and three-light side-lights. The door is sheltered by a small entry porch decorated with lattice work and accessible by a wide flight of steep stairs from the north. The windows and door have plain board surrounds with shallow pediments. At loft level in both north and south gable ends is a small triangular window.

On the three-bay west side of the house, there is a narrow central peaked gable lighted by a five-pane pointed-arch window. A one-story porch with turned posts runs the full length of this west side at first story level; it is entered from the stairhall of the house by a door in the first bay of the west facade, and is not accessible from the outside.

The north and south gable ends, as well as the central peaked gable on the west facade, are ornamented with elaborate bargeboards, with running S-shaped swirls; at the apex of each is a tall finial.

The original German siding is presently covered with asbestos shingle painted light green. The roof has recently been covered with synthetic shingle. There is a large central brick chimney.

At ground (basement) level on the south is a shed-roofed porch with turned posts, now enclosed by screening.

The interior plan of the house consists of a front and back parlor on the east, with fire places back-to-back in their common wall. The mantel in the rear (south) parlor is of wood, while that in the front (north) parlor is of heavy marbleized slate with a central keystone ornament. The west third of the house consists of the stairhall; rising from both the basement level and the first story are staircases with heavy arts-and-crafts style newel-posts, and turned balusters. The architraves of doors and windows feature heavy multiple-course ovolo moldings without corner blocks. The basement once included a full-kitchen in the south (rear) and pantry/larder in the north; until the 1950's, when indoor plumbing was installed, there was a cistern in the basement for all indoor water uses. (The narrow-width floorboards of the basement appear to rest directly on the sand below).

The double-lot also includes (southeast of the house) the original frame carriage house with board-and-batten siding. This carriage house was at one time converted into a tenant dwelling with the installation of a chimney and stove pipe, as well as partitions. It is now in ruinous condition, and beyond salvage.

The H.A. Kelly house is the only one of three Victorian cottages remaining in near-original condition in the town of Seabrook. It may be the only structure of its genre (i.e. a cottage built in a planned rural retreat) in Prince George's County today, and as such it is the prototype for the other two Seabrook cottages, once identical but much altered in recent years.

The retreat community of Seabrook was developed by Thomas Seabrook, a Philadelphia engineer for the Pennsylvania Railroad who had been instrumental in designing the railroad tunnels through Baltimore, and laying out the lateral branch (now the main line) from Bowie Junction into Washington.<sup>1</sup> In 1871, Seabrook purchased 223 1/4 acres of a tract called "Webb" and 275 adjoining acres, and a decade or so later began to lay out a resort community, easily accessible from the city of Washington by rail.<sup>2</sup>

Three Victorian cottages were constructed before 1888; the westmost was used by Seabrook and the other two probably by his friends and colleagues as vacation residences. In 1896 Seabrook sold the eastmost of the three cottages (the subject property) to Henry A. Kelly, of the U.S. Post Office Department. It remained in the Kelly family until 1938 when his widow, Mary M. Kelly, willed it to her sister, E. Ellen Brickerd. During World War II the present owners rented rooms in this house, and then purchased it in 1951.<sup>3</sup> Since that time the house has been fully electrified, and the cistern has been replaced by indoor plumbing, but the house remains essentially in its original condition. Its significance lies in the fact that it is probably unique in Prince George's County, and can serve as a model for potential restoration of the other two cottages.

STATEMENT OF SIGNIFICANCE

The houses were built on land owned by Seabrook, a surveyor for the Philadelphia-Washington section of the Baltimore and Ohio Railroad. One house was his own residence and the other two were rental properties.

Two of the houses have been altered. 9409 has had the porch enclosed and the finials shortened. 9431 (?) has had the the west porch removed and the bargeboards replaced with fasciae. Both buildings are restorable, however, since 9513 retains an almost pure original character.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

These three houses are identical in plan and original appearance. They were built by Seabrook in the mid-19th century; 9409 Duberry Avenue, being his own house and the other two being rentals.

The houses are 1-1/2 story, frame structures, sitting on high brick foundations. The entrance (north) facades are two bays, the westerly being a doorway with tall transom light and low-pedimented architrave, the easterly being a bay window. In the forward facing gable is a triangular window, the sides of which are segmental arches.

Only 9513 retains the original west facade treatment. A one story porch runs across the two bay facade. The north bay is a doorway with a tall transom light and the south bay is a tall window; both openings have low-pedimented architraves. The west-facing gable is extremely narrow, giving it a vertical appearance; it has a narrow, tall, triangular-arched window.

Features which distinguish these houses are central chimneys larger than those usually found on mid-nineteenth century houses, elaborate bargeboards consisting of a series of interconnected S curves, and tall finials in the gables.


