Description

The Bald Hill School is situated to the west of the residence at 8701 Old Brown's Lane. It is presently used for storage and is in very bad repair. The building is frame, one-story, measuring 18 x 24 feet, with a shed roofed frame, one-story addition on its south side. The gable roof is covered with corrugated metal. The north facade has a 3 panel wooden door, east of the facade center line, and a window opening west of the door. The first bay of the south facade has an entrance door of wide vertical boards with a horizontal board at the top, center and bottom. It has exterior, triangular-shaped hinges and a wide, plain wood surround. There is a boarded window on the second bay of the facade, with a wide lintel and sill of rough siding. The interior has wide horizontal siding, painted white, with initials carved into the interior walls by the school's students. The ceiling is of narrow board paneling, also painted white. The ceiling boards are coming down and lath shows through on the walls. The wood flooring in the building is partially rotted away. The building appears to rest directly on the ground, with no foundation or support piers. The corner posts, exposed through the exterior siding, are large, square, finished posts which appear to be hand hewn.

Significance

The Bald Hill School, named for the ridges on which it was situated, was the first in the Lanham area. The construction date of the building is believed to be before the establishment of the Board of County School Commissioners in 1865, because of the survival of a Bald Hill School Record book dating from 1861-62. By 1885 the Board of School Commissioners was attempting to sell the acre of land the school was built upon and seeking bids to build a new Lanham school. The school house and lot were sold in 1906 to David Fairchild, who had acquired the property surrounding the school lot. The school was moved from its original site at 5613 Westgate Lane to its present site at 8701 Old Brown's Lane by Edgar Brown in 1906, to be used as a cow shed.

The Bald Hill School is one of a few examples of mid-19th century functional vernacular buildings remaining in the county. The interior, though deteriorated, remains unchanged from when it was used as a school. Initials carved by students on the interior and exterior document its original use.

The Bald Hill School building was originally located at 5613 Westgate Lane. It was moved early in the 20th century to its present location at 8701 Old Brown's Lane. The building is situated to the west of the residence at 8701 Old Brown's Lane, in a large side yard. It is shaded by a very large linden tree at its north east corner. It is presently used for storage and is in very bad repair.

The building is frame, one-story, measuring approximately 18 x 24 feet. The gable roof was wood shingled, but is now covered with corrugated metal. The building has unpainted horizontal siding of varying width. The siding is wider on the west gable end than on the north and south facades.

The north facade has a three-panel wooden door, east of the facade center line. Siding piled against the building hides the window opening west of the door. The west gable end has a plain raking cornice. Centered on the west facade is a rectangular window opening that has been boarded over. The window has a plain, narrow wood surround. There is a square opening east of the window near ground level on the facade.

The south side of the building has an entrance in the first bay, through a board and batten door. It has exterior, triangular-shaped hinges and a wide, plain wood surround. There is a boarded window on the second bay of the facade, with a wide lintel and sill of rough siding. There is a shed roof, frame, one-story addition on the south side of the building. It is in very deteriorated condition.

The interior of the school has wide horizontal siding, painted white. There are initials carved into the interior and exterior walls, presumably by the school's students. The ceiling is of very narrow board paneling, also painted white. The ceiling boards are coming down and lath shows through on the walls. There is wood flooring in the building which is partially rotted away, exposing the ground underneath. The building appears to rest directly on the ground, with no foundation or support piers. The corner posts are exposed through the exterior siding at some points. They are large, square, finished posts which appear to be hand hewn.

Prepare both a summary paragraph of significance and a general statement of history and support.

The Bald Hill School was the fourth school in the Bladensburg School District and the first in the Lanham area.¹ It was situated on the ridge that forms the watershed between the Patuxent and Potomac Rivers. The ridge apparently was sparsely vegetated at one time, hence the name Bald Hill. One source credits Basil Ridgeway, a local landowners, with donating the land and building the school house.² The school was built prior to 1872, when the railroad's passage through the area gave it the popular name of Lanham's Station. The construction date of the building is uncertain but it is believed to be before the establishment of the Board of County School Commissioners in 1865 because of the survival of a Bald Hill School Record book dating from 1861-62. The school appears in its original location on the Hopkins Atlas of Prince George's County 1878.

By 1885 the Board of School Commissioners were attempting to sell the acre of land the school was built upon and seeking bids to build a new Lanham area school.³ The school house and lot were eventually sold in 1906 to David Fairchild, who had acquired the property surrounding the school lot.⁴ The building was moved from its original site at 5613 Westgate Lane to its present location at 8701 Old Brown's Lane by Edgar Brown, around 1906, to be used as a cow shed.⁵ It is still in use as a storage shed at this time.

The Bald Hill School is one of a few remaining examples of mid-19th century functional vernacular buildings in the county. It is an example of a type of building which was once commonly in use as a school house, store, residence, meeting house or outbuilding. The finished interior, though deteriorated, remains unchanged from when it was used as a school. Initials carved by students both on the interior and exterior of the building document its original use.


