Description:

The Smith house is a two-and-one-half-story L-shaped frame house with the principal facade facing west, and a porch tower set into the inside (west) corner of the ell. The main house consists of two sections: A (north), the ca. 28' east-west leg of the ell; and B (south), the ca. 40' north-south leg of the ell. Entrance is on the west in the first bay of B, and is sheltered by the two- and one-half story pyramidal-roofed porch tower. The tower has balustrades with flat jig-sawn balusters on both first and second stories. The west gable-end of A, which forms part of the principal facade, has double 1/1 windows on both first and second stories, surmounted by bargeboards with jig-sawn tracery filling the apex of the gable. The original German siding is covered with white asbestos shingle, and the original wood-shingle roof has been replaced with fish-scale patterned tin. There are two major additions attached to the rear (east) of the house.

Significance:

The Smith house is one of northern Prince George's County's few surviving houses of the early twentieth century which exhibit ornamental detail from the end of the Victorian period. The property, just outside (north) of the railroad-junction town of Bowie, was purchased in 1899 by Mary Smith; in the next decade, she and her husband, Albert Smith, himself a carpenter, hired Millard Schafer (a local housebuilder) to construct a house on the property, probably incorporating an earlier, small dwelling. The result was a handsome structure with prominent tower and jig-sawn detail, which became a landmark on the road toward Laurel. The Smith family remained in the house until 1928, when the property was sold to Marvin Bischoff, whose family remains there today.

The Smith House is a two and one-half story L-shaped frame house, with the principal facade facing west, and a porch tower set into the inside (west) corner of the ell.

The main house consists of two sections: (A) to the north, the ca. 28' east-west leg of the ell, and (B) to the south, the ca. 40' north-south leg of the ell. Entrance is on the west in the first bay of Section B, and is sheltered by the two and one-half story pyramidal-roofed porch tower.

The west gable-end of Section A which forms part of the principal facade, has double 1/1 windows on both first and second stories, surmounted by bargeboards with jig-sawn tracery filling the apex of the gable. The south gable-end of Section B has the same treatment. The porch tower has balustrades with flat jig-sawn balusters on both first and second stories.

The house rests in foundations of local iron-bearing stone. The original siding was German siding, now covered with white asbestos shingle. The roof, originally wood shingles, is now of fish-scale patterned tin. There are two major additions attached to the rear (east) of the main house.

The interior of the main house consists of a central stairhall running east-west from the main entrance, one parlor to the south in Section B, and two adjoining parlors to the north in Section A. Brick chimneys with corbelled caps serve fireplaces in these rooms. The interior features door and window surrounds with bulls-eye corner block moldings.

A photograph in the possession of the present owner shows this house when it was first built. This photograph shows that the main porch originally extended (on the first story) all the way across the west front of Section B; it also clearly shows the original wood-shingled roof and German siding.

To the south of the house stands a small barn, now converted into a garage. It is possible that this garage stands on the site of an earlier sawmill.

Prepare both a summary paragraph of significance and a general statement of history and support.

This is one of northern Prince George's County's very few surviving houses of the early twentieth century which exhibit ornamental detail from the end of the Victorian period. It is located just outside (north) of the town of Bowie on the road leading to Laurel.

The house stands on land (owned since 1882 by the Hale family) on which at the end of the nineteenth century there stood a sawmill.¹ In 1899 the 6-1/2 acre Hale property was purchased by Mary R. Smith; in the next decade she and her husband, Albert Smith hired Millard Schafer (a local house builder) to construct a house on the property, probably incorporating an earlier, small dwelling. The result was a handsome structure with prominent tower and jig-sawn detail, which became a landmark on the road north of Bowie. Albert Smith had served as a carpenter for the U.S. Government, and ca. 1908 (after the construction of St. James Episcopal Church in Bowie) he built the altar in the new church.²

The Smith family lived in the house until 1928, when the house and 3.6 acres, as well as another parcel west of the Laurel-Bowie Road, were sold to Marvin Bischoff.³ Bischoff's family remains there today.




