DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

These are some very run-down farm properties, being held for development. A Federal-style, frame house (shown in a PRINCE GEORGE'S POST article in 1968) has apparently been removed. However, two separate hilltop cemeteries are still visible. One contains 3 stones, and the other (100 yards south) contains a single marker for Major Thomas Lansdale (born 1748, died 1805)-a Revolutionary War veteran. Plans to develop this property by Levitt & Sons, Inc. are imminent.

STATEMENT OF SIGNIFICANCE

These are 2 old family cemeteries here that merit preservation. The Levitt development has engulfed a number of historic sites, and few of them have been preserved. Apparently, this farm was owned by Nicholas H. Shipley in 1861, and by Charles Clagett in 1878. The adjacent farm, to the SW, was a Duvall property.
