Description

The Palmer-Duvall House is a two-story gable roof frame dwelling, three-by-two bays, of rectangular plan, situated on a 1.6 acre lot in a suburban residential area. The three bay east (main) facade has central entrance through a door surmounted by a transom. Windows are 2/2 sash. Both windows and door have a wide plain board surround. The four-bay shed roof entrance porch wraps around the northeast gable end and continues for one bay across the north facade. Its boxed cornice has decorative metal scroll pendants, and rests on square wood posts with rectangular brackets. The house is covered with asbestos shingle, has a standing seam metal roof with a boxed wood cornice on the east and west and a plain raking cornice on the north and south gable ends. The structure rests on a cement foundation. The house is set on a knoll overlooking Addison Road. There is a mature maple tree east of the house. Boxwoods line the northeast and southeast corners of the building, and there is a grape arbor to the south. West of the house is a 1 x 1 bay rectangular board and batten outbuilding with a hipped roof surmounted by a finial, which appears to date to the construction of the house.

Significance

The Palmer-Duvall house, dating from the 1890's, is significant for its vernacular architecture. It is one of the earliest houses in the Seat Pleasant subdivision. It also is significant as the summer home of George Palmer, was instrumental in the development of the village of Seat Pleasant and in the development of Prince George's County. The house was built as a suburban home by George Palmer's father, listed as a government printer in the 1900 census. Palmer acquired 13 acres, Lot 16 in Seat Pleasant in 1884. The house was built in the late 1890's. The four Palmer sons were trained in the construction trades. They were responsible for much early twentieth century house construction in Seat Pleasant. George Palmer served as a County Commissioner, chairman of the Maryland-National Capital Park and Planning Commission, and president of the Seat Pleasant Building and Loan Association.

The Palmer-Duvall House is a two-story gable roof frame dwelling, three-by-two bays, of rectangular plan. It is situated on a 1.6 acre lot in a suburban residential area.

The three bay east (main) facade has central entrance through a door with an upper glass light and three lower panels, surmounted by a transom. Windows on the facade are 2/2 double hung sash. Both windows and door have a wide plain board surround. The four-bay shed roof entrance porch wraps around the northeast gable end and continues for one bay across the north facade. The porch rests on cement block piers and has a standing-seam metal roof. Its boxed cornice has decorative metal scroll pendants. The roof rests on square wood posts with rectangular brackets, and the porch is encircled by a balustrade.

The house is covered with asbestos shingle and has a standing seam metal roof. There is a boxed wood cornice on the east and west elevations and a plain raking cornice on the north and south gable ends. The structure rests on a cement foundation.

The two bay north gable end has entrance in the first bay, sheltered by the one bay section of the main entrance porch. The two bay south gable end has a square 2/2 sash window centered in the upper gable. There is a centered cellar entrance in the foundation, reached by a flight of stairs.

The three bay west (rear) facade has a small centered 6/1 sash window placed high on the first story level. A one bay shed roof screened porch shelters a rear entrance in the third bay. A parged chimney projects from the west roof slope.

The house is set on a knoll overlooking Addison Road. The Seat Pleasant Police Station east of the house is situated on what was the front of the Palmer lot. There is a mature maple tree east of the house. Boxwoods line the northeast and southeast corners of the building, and there is a grape arbor to the south. West of the house is a 1 x 1 bay rectangular board and batten outbuilding with a hipped roof surmounted by a finial, which appears to date to the construction of the house. It has a six light window on the north elevation and a four-panel door on the east. In close proximity is a 2 x 1 bay outbuilding with vertical board siding and a shed roof, which is of more recent construction.

The Palmer-Duvall house, dating from the 1890's, is significant for its vernacular architecture. It is one of the earliest houses in the Seat Pleasant subdivision. It also is significant as the summer home of George Palmer, who during the late nineteenth and early twentieth century was instrumental in the development of the village of Seat Pleasant and in the development of Prince George's County.

The house was built either as a summer home or a suburban home by Joseph Palmer, George Palmer's father. Palmer was listed as a government printer in the 1900 census, and was aged 54 at that time. The Palmer children were all born in Washington, D.C.¹ Palmer acquired 13 acres, Lot 16 in Seat Pleasant in 1884.² The house appears to have been built in the late 1890's.³ The Palmers apparently were residents of Seat Pleasant by 1900, as they were recorded by the census there.

The Palmer sons, including George, Joseph Jr., William and Edwin were trained in the construction trades such as house carpentry and brick masonry.⁴ The Palmers subdivided their own lot into 5 lots in 1907.⁵ Two of the lots George Palmer and Joseph Palmer, Jr. built their own dwellings upon. The Palmers were also responsible for much early twentieth century house construction in Seat Pleasant. George Palmer, who served as a County Commissioner and chairman of the Board of the Maryland-National Capital Park and Planning Commission, also was president of the Seat Pleasant Building and Loan Association.⁶

The Palmer-Duvall house was deeded by Joseph Palmer and his wife to a daughter, Virginia Duvall, in 1923. The Duvalls and their descendents owned the property through 1984.

The Palmer-Duvall house is a plain vernacular dwelling with Victorian stylistic elements. Its antecedents are late nineteenth century rural farm dwellings rather than stylish Victorian suburban homes. It stands on its large lot in densely developed surroundings as a reminder of Seat Pleasant's more rural beginnings.


