The Davis House is located at the southeast corner of Central Avenue and Shady Glen Drive behind a modern house that fronts on Walker Mill Drive, just outside Seat Pleasant, in Prince George's County, MD. The house is vacant and in deteriorating condition and does not qualify for individual listing on the National Register of Historic Places.

Probably built in the first decade of this century, the Davis House is a two-story, central-passage frame dwelling. It is set upon a brick pier foundation, is clad with German siding and is covered with a gable roof, featuring a central front gable. A single-story porch with a half-hipped roof extends across the central bay of the facade, which was originally five bays wide, but has been reduced to three by the elimination of window openings on the first and second stories. A small, one-room shed addition projects from the rear elevation of the house. The original five-panel wood door and its transom is intact, as are the typical 2/2 windows.

The house is a representative example of the vernacular domestic building forms of the period and is well-represented in the region and in this area of Prince George's County. The house lacks the architectural distinctiveness necessary to qualify for listing on the National Register under Criterion C. The property is not known to have any associations with persons or events significant to our past and does not, therefore, qualify for listing under Criteria A or B.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The house at 7430 Walker Mill Drive is an I-house built around the turn of the century. This vacant house stands close to the southeast corner of Central Avenue and Shady Glen Drive behind a modern house that fronts on Walker Mill Drive. The house stands in a clearing but to the front of the house and also to the north of the house along Central Avenue, there is some vegetation consisting of low shrubs and medium size trees.

The two-story structure is a ca. 1900-1910 I-house. It rests on a brick foundation and has novelty board siding (except for the north gable end which has asbestos shingle siding) and an asphalt shingled gable roof with a central front gable on the west facade. A central brick flue is found on the ridge line. The three-bay front elevation is symmetrical with its original five-panel wood door and transom above. A single window is on each side of the door. The sash within the window openings on these and most other windows on the structure is modern replacement sash. Several window openings have obviously been shortened and infilled below the modern windows with board siding. A hipped roofed porch has a wood deck on brick piers, slender post supports with beveled bases and caps and a simple wood rail and balusters. A diamond shaped vent is found in the central gable. Each end elevation has a single window on each floor and a rectangular vent above. The three-bay rear elevation has a one-story shed addition encompassing two bays and a window in the third bay. On the second story are three windows. The interior was inaccessible.

The house at 7430 Walker Mill Drive is an early 20th century I-house, a house type common in Prince George's County. The house has undergone numerous alterations including new windows installed in larger original window openings.

The farmhouse appears to have been constructed around the turn of the century. Like the nearby I-house at 7308 Central Avenue, this may have originally served as a tenant farmers house. According to local tradition, it is associated with the farmhouse at 7770 Walker Mill Drive, another turn of the century farmhouse that has experienced extensive alterations. Around the 1950s, A.A. Davis constructed a small minimal traditional type house on the this small lot at the far northwest corner of the old farm. The farmhouse now stands vacant behind the 1950s house.







DETAIL of House
