Description:

The Carmody house stands on a ca. one acre lot, now surrounded by other subdivision lots, approached by a flagstone walk and steps. It is a large frame cross-gable dwelling with a rear ell addition. The two-and-one-half-story main block is two bays (one room) deep, and seven bays long, with a projecting off-center cross gable on both front and rear elevations. Entrance is in the fifth bay of the main (south) facade (the first bay east of the cross gable), through a door with sectioned fanlight and four-pane sidelights. A one-story screened porch wraps around most of the main block of the house, sheltering the east, south, west and most of the north facades. Its turned posts are still visible in the screen enclosure. Extending north, flush with the east gable end of the main block, is a rear ell wing, two bays long and two stories high. The main block is covered with narrow board siding painted white, and the foundation appears to be of concrete block. The wing is covered with aluminum siding, and its foundation is of poured concrete. The entire roof is covered with slate shingle. Windows are large 6/6 double hung sash with plain board surrounds and black louvered shutters.

Significance:

The Carmody house is important in that it is one of few examples of rural residential architecture in the inner-Beltway area. It also was the home of Francis S. Carmody, an early developer of Seat Pleasant. It was built in several stages, the first being at the beginning of this century, with two major building phases since that time. The land was part of the William Wilson Hill homestead known as Glenway. The western part of the farm was sold in 1893 to Zeph Fenno. Fenno had a small dwelling (which may be the nucleus of the Carmody house) on his 64-acre farm, which he sold to Mary Carmody in 1898. By 1905 the Carmodys had constructed a substantial house which they enlarged in the 1920's. From 1913-17 Francis Carmody was president of Seat Pleasant's first bank. In 1924 the property west of the house was subdivided and developed into Carmody Hills, and in 1928 Mrs. Carmody sold the house and adjoining property to Maud Hobbs. The Hobbs family held the property until 1957, during which time they constructed the north wing. Since then the land around the house has been subdivided and the Carmody house is now surrounded on three sides by the small tract houses of the Independence Estates Subdivision. It is an outstanding visual feature in a densely developed community.

The Carmody house stands on a ca. one acre lot, now surrounded by other subdivision lots, approached by a flagstone walk and steps. It is a large frame cross-gable dwelling with a rear ell addition. The two-and-one-half-story main block is two bays (one room) deep, and seven bays long, with a projecting off-center cross gable on both front and rear elevations. Entrance is in the fifth bay of the main (south) facade (the first bay east of the cross gable), through a door with sectioned fanlight and four-pane sidelights.

There is an exterior brick chimney north of the ridge at the east gable end which serves a fireplace in the living room. The boxed cornices have a crown molding. Windows are large 6/6 double hung sash with black louvered shutters and plain board surrounds. The entrance leads into a stairhall, which in turn leads into a living room on the east, (central) sitting room and (end) dining room on the west. The interior stairway, mantels and moldings uniformly reflect a colonial revival style that probably dates to the 1940's.

A one-story screened porch wraps around most of the main block of the house, sheltering the east, south, west and most of the north facades. The porch rests on brick and concrete piers. Its turned posts are still visible in the screen enclosure.

Extending north, flush with the east gable end of the main block, is a rear ell wing, two bays long and two stories high. This wing also dates to the 1940's. It contains an enclosed stair, a study on the first floor and a bedroom above.

The main block is covered with narrow board siding painted white, and the foundation appears to be of concrete block. The wing is covered with aluminum siding, and its foundation is of poured concrete. There is a full basement under both sections. The entire roof is covered with slate shingle.

Directly behind (north of) the house is a small frame one-story gable roofed building, with German siding, asphalt shingle roof, and concrete foundation. It appears to have been built in two sections and probably dates to the construction of the house. The larger back section has a large wooden door set on metal rolling tracks, and contains a horse or cow stall. Immediately north of this is a modern brick garage.

In the front yard is a very large maple tree. The surrounding yard is full of mature bushes and trees.

The Carmody house is important in that it is one of very few surviving examples of rural residential architecture in the densely developed inner-Beltway area. It is also important as the home of Francis Simon Carmody, an early developer of Seat Pleasant. The house was built in several stages, the first being at the beginning of this century (possibly as early as 1895), with two major building phases since that time.

The land on which the Carmody house stands was part of the William Wilson Hill homestead known as Glenway. The western part of the farm was sold in 1893 by one of the Hill heirs to Zeph Fenno (the Glenway house was on the eastern part). Fenno had built a small dwelling (which may be the nucleus of the Carmody house) on his 64-acre farm, which he sold to Mary Carmody in 1898.<sup>1</sup> By 1905 Francis and Mary Carmody had constructed a substantial house which they enlarged in the 1920's.

Francis Simon Carmody is listed in the Washington, D.C. City directory from 1900 through 1918, with a residence in Seat Pleasant, Maryland. He first is listed as the general manager of the F.S. Carmody Construction Company, located at 1413 G Street, N.W. and specializing in foundations. From 1913-1917 Carmody is listed as the president of the Farmers and Mechanics Bank of Seat Pleasant. In 1918 he is listed as president and treasurer of Hendeson Motor Car Company. He then disappears from the book.<sup>2</sup>

It is likely that Carmody facilitated the rapid development of Seat Pleasant in the first two decades of the 20th century, both as a contractor and as a banker. He also helped establish St. Margaret's Catholic Church on Addison Road, County Historic Site P.G. #72A-7-1. In 1908 Carmody purchased the lot for the church and supplied the building materials.<sup>3</sup>

By 1905 the Carmody family had constructed a substantial house which they enlarged in the 1920's. During the 1920's part of the Carmody property west of the house was subdivided and developed into Carmody Hills, and in 1928 Mrs. Carmody sold the house and adjoining property to Maud Hobbs. The Hobbs family held the property until 1957, during which time it is probable that they constructed the north wing. Since that time the land around the house has been subdivided into small lots, and the Carmody house is now surrounded on three sides by the small tract houses of the Independence Estates Subdivision. It is an outstanding visual feature in a densely developed community.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an attractive, L-shaped, two-story frame farmhouse, that is engulfed by a number of subdivisions. However, there appears to be a parcel of remaining farmland to the rear, that extends NE to the corner of F street and Hill Rd. The main section of the house is a three-bay part, that faces south. The entrance is in the west end bay, where the house is joined to a two-story ell. This door has transom and sidelights. The large windows all have 6/6, old sash and glass. Siding is clapboard, and the roof is covered with slate shingles. The ell that joins on the west is of similar styling. A modern screen porch covers the entire (south) front of the house at the first floor level. The H.A.B.S. house, "Independence", that stood nearby at the bend in 77th St., has recently been destroyed. A new house sits on the lot it occupied. Its last reported use was as a children's nursery school.


