Description

The Warington Tobacco Barn is a gable-on-hip-roof tobacco barn, with aisles on all four sides. The central block is a tall rectangle with steeply pitched gable roof. It is sided with vertical board, some of which is hand-split. Hewn corner posts are pegged to the hewn top wall plate; four posts make up the short ends, and six posts make up the long sides of the central rectangle. There are four horizontal girts between the hewn sill beam and the plate. Four collar beams connect the rafters, and are joined to the rafters by nailed dovetail joints. The roof is covered with wood shingles over corrugated metal. The hewn sill beams rest on chunks of concrete, which probably replace original chunks of local stone. The long side aisles may be original to the structure, while the shorter end aisles may have been added. There is one opening centered in each of the shorter end walls. A large double door, hung on long strap hinges, is centered in the wall of the north long aisle. The south aisle consists of three large openings. The barn stands in an open field a short distance south of the entrance drive into the Newton White Mansion and Golf Course.

Significance

The Warington Tobacco Barn is probably the best surviving example in Prince George's County of a nineteenth century tobacco barn. It was constructed, shortly before the Civil War, by Marsham Waring, who, became one of the County's most successful planters. The tobacco barn, constructed probably in the 1840's or 1850's, is an effective reminder of the prominence of Waring's plantation. Waring died in October 1860, and devised to his wife the plantation, Warington, on which they resided. The property passed to his daughters, Virginia Mackubin and Elizabeth Bowie, and in this century to his granddaughter, Amelia Belt. It was sold in 1937 to Newton H. White, Commanding Officer of the U.S.S. Enterprise, who built a handsome brick mansion in 1939, and developed the estate into a model dairy farm, known as the Enterprise Estate. The 585-acre farm was sold by his widow in 1971 to the M-NCPPC; the mansion now serves as a reception hall, and the grounds have been developed into a golf course. The prominent profile of the barn makes it an outstanding landmark; it is probably the best surviving example of a nineteenth century tobacco barn in Prince George's County.

The Warrington Tobacco Barn is a gable-on-hip-roof tobacco barn, with aisles on all four sides. The long side aisles may be original to the structure, while the shorter end aisles may have been added.

The barn is of braced frame construction. The central block is a tall rectangle with steeply pitched gable roof. It is sided with vertical board, some of which is hand-split; much of the vertical board siding on the side aisles is circular sawn. Hewn corner posts are pegged to the hewn top wall plate; four posts make up the short ends, and six posts make up the long sides of the central rectangle. There are four horizontal girts between the hewn sill beam and the plate. The rafters are adzed, but their junctures with the posts could not be observed. There are four collar beams connecting the rafters; they are joined to the rafters by nailed dovetail joints. There is only one purlin on the south plane of the roof. The roof is covered with wood shingles over corrugated metal.

The hewn sill beams rest on chunks of concrete, which probably replace original chunks of local stone.

The siding of the aisles is largely made up of circular sawn board, but it is possible that the original structure did have long (north and south) side aisles; there are no visible nail holes for siding on those parts of the central rectangle. The shorter end aisles are almost certainly additions; nail holes for original exterior siding on the central rectangle are apparent in these locations. The long north and south top plates have been extended in length to incorporate these east and west aisles.

There is one opening centered in each of the shorter end walls. A large double door, hung on long strap hinges, is centered in the wall of the north long aisle. The south aisle consists of three large openings.

There is a large oak growing at the northeast corner of the barn. The barn stands in an open field a short distance south of the entrance drive into the Newton White Mansion and Golf Course. South of the barn is a hedgerow which separates the golf course grounds from a cultivated field.

After Marsham Waring's death in 1860, the property passed to his two daughters, and finally, in 1937, was purchased by Newton H. White, who erected the brick mansion which now stands near the graveyard. After distinguished service in the Navy during World War II as Commanding Officer of the U.S.S. Enterprise, White devoted the balance of his life to developing a model dairy farm on his Mitchellville estate. In 1971, his widow sold the 585 acre farm to the Maryland National Capital Park and Planning Commission.

STATEMENT OF SIGNIFICANCE

The White farm is located on the tract known as Warington, a mid-19th century name given to several parcels of land including parts of Heart's Delight and St. Andrews, once owned by Marsham Waring. At the time of his death in 1812, Waring's property included "a roomy and comfortable wooden dwelling house, with cellars, kitchen, stable and other outhouses , , ,". Waring's son, also Marsham Waring, lived on this farm until his death in 1860, and it was during his lifetime that the tobacco barn was built. His was the first body interred in the "Catholic Burying Ground of Marsham Waring" which is preserved on the property. The property passed to Waring's daughters, and finally, in 1937 was purchased by Newton H. White, who two years later erected the brick mansion which now stands near the graveyard. After distinguished service in the Navy during World War II as Commanding Officer of the U.S.S. Enterprise, White devoted the balance of his life to developing a model dairy farm on his Mitchellville estate.

In 1971, his widow sold the 585 acre farm to the Maryland National Capital Park and Planning Commission.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 600 acre farm complex, built on the site of the 18th Century Waring family homestead "Heart's Delight". The old brick and frame house stood until 1939-when it was dismantled, and its frame wing moved north near the present stables. It is now a tenant house. The bricks were used to construct a one-story home that sits east of the barns. The old house site has been occupied by the present mansion, built by the Whites in 1939. It is a large, brick, Georgian Revival structure-that was designed by architect William S. Bottomly, and built by Robert Johnson. East of the house, along the entrance driveway, is an old tobacco barn-with a very steeply-pitched A-roof, and sloping, shed-roof "skirts" at its base. West of this is the old Waring family burial plot, that is enclosed by a decorative iron fence. The tile barns are also notable, as this was a model dairy farm in the 1900's.






