 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two-story, frame building, with a gabled entrance facade, that faces north on Marlboro Pike. The main facade here is two bays wide, and the building is three bays deep. A hip-roofed porch spans the front. It has 6/6 windows and German siding. The form-stone foundation indicates this house was probably built in the early 1900's. However, it may have been a hotel or guest house at one time. The Carrico family did operate a hotel near here in the late 1800's.
