Description:

The Collins House is a two-and-one-half-story L-shaped gable-roofed frame house with a projecting one-bay tower centered in the three-bay (south) facade. Entrance is through a doorway in this central tower; the door has transom and sidelights. At loft level the tower has cross-gable roof, returned cornice, and a diamond-shaped window. Across the main (south) facade is a one-story porch, supported by plain columns, square in section; this porch has a shallow central pediment. The main block of the house is one bay deep. Extending to the rear (north) at the east gable end is a rear wing, making the house L-shaped. Windows are 2/2, and the siding is white asbestos shingle; the roof is covered with synthetic shingle, and foundations are of concrete. In the front yard, located southeast of the house, is a small frame gable-roofed outbuilding which rests on a high brick foundation.

Significance:

This is a modest dwelling house which reflects a style (with central projecting tower) which was very popular in Prince George's County at the end of the nineteenth century. It was probably built ca. 1892 by Andrew Schwartz, a German real estate agent who had settled in Forestville in the 1870's. Within a few years, the house and ca. 4 acre lot was purchased by the family of George Dove, a merchant who operated a general store on the lot across the road. In 1920, Dove sold the house and lot to his daughter and son-in-law, and it has remained in the possession of their heirs to the present day. In the early 1970's, when Marlboro Pike was widened, the house was moved a short distance to the north, away from the road. It stands today, surrounded by commercial development in a rapidly changing area, as an example of a once-popular local style of domestic architecture.

It was probably built ca. 1892 by Andrew Schwartz, a German real estate agent who had settled in Forestville in the late 1870's.¹ Within a few years the house and ca. 4 acre lot was purchased by George Dove, a merchant was operated a general store on the lot across the road.² (This was the main road, Old Marlboro Pike, which ran through Forestville, known earlier as Long Old Fields.) In 1920, Dove sold the house and lot to his daughter and son-in-law, Edna and Norman Collins, and it has remained in the possession of their heirs to the present day.³ In the early 1970's, when Marlboro Pike was widened, this house was moved a short distance to the north, away from the road, on the same lot.⁴ It stands today, in fair condition, surrounded by commercial development in a rapidly changing area, as an example of a once-popular local style of domestic architecture.

This is a country Victorian house, that faces south on Marlboro Pike. The main facade has three bays, with the central (entrance) bay being formed by a slim, projecting tower. The tower is capped with its own gable-roof, that features a returned cornice and diamond-shaped window. The doorway has transom and side-lights. A one-story, open porch (with a low, pedimented center gable) crosses the front. There is a stove-chimney at the NE rear of the house, where there is a shed-roof wing. Windows are 2/2, and present siding is asbestos shingle.


