<p>The area is an early twentieth century suburb that includes a block of one story commercial buildings and bungalow residences. There are also several larger houses. One is a one story, colonial revival building with a pedimented portico and long wings. Another is a two story, brick building. A third is a two story frame house with a central entrance tower and flanking windows.</p> <p>The commercial buildings are generally brick, with central doorways and large display windows. The cornices rise above the roof line to form a parapet. There is a large, two story, brick school of the 1930's period, with large windows and neo-Georgian entrance.</p>
