DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a run-down old house, that sits on the hill above "new" Branch Ave., opposite the post office building. It faces east, and has a narrow, three-bay, gable facade. The door is in the south end-bay. A one-story, open porch, with railing and turned, bracketed posts, spans the front. Windows have shutters (now closed), and there is a smaller, 6 pane window in the gable-end. The cornice is returned at the gable-ends, and the siding is German siding. A small, shed-roof wing extends from the south rear.


