The Marden House is a late 19th century dwelling situated on a knoll overlooking Webster Lane and Allentown Road. It is presently surrounded by subdivision development, a county park, and an elementary school. It is a two-story gable-roofed frame dwelling with an unusual plan, reflecting alterations and additions. The main block is based on the ell plan with the east elevation of the ell forming the principal facade. A two-story wing extends from the rear, west elevation, of the main block, forming an overall T-plan. An external gable-end brick chimney is located at the south elevation of the ell. It rests on a one-story base and has a freestanding stack. Another external brick chimney occupies the central bay of the north elevation of the main block and appears to date from a later period.

The present house was rebuilt on the foundations of an earlier house which burned approximately 100 years ago. The rear wing was constructed at that time. The house rests on a brick foundation and has a partial basement. It is covered with wide weatherboard siding, and has 6/6 sash windows. Asphalt shingles cover the gable roof.

The interior has been altered; many original partition walls have been removed to allow for larger sized rooms. One interior feature is of special note - a cast-iron "Catoctin" grate and fireback. It occupies the newer of the two fireplaces, suggesting either that it survives from the earlier house and was moved, or that it was added at a later time.

A garage is situated immediately southwest of the house. It is of log construction and covered with board and batten siding. According to the present owner, Edward Lane, it was used as a sweet potato storehouse in the 19th century, and was used as a temporary dwelling by the Marden family while their house was being rebuilt after the fire. It has been greatly altered in the 20th century for use as a garage. A small apartment occupies the loft space above the garage.

The Marden House is a modest, late 19th century frame, Prince George's County farmhouse which has undergone some alterations. The farm was owned by the Marden/Shreve family from 1845-1958.

It rests on a one-story base and has a free-standing stack. Another external brick chimney occupies the central bay of the north elevation of the main block and appears to date from a later period.

The present house was rebuilt on the foundations of an earlier house which burned approximately 100 years ago.<sup>1</sup> The rear wing was constructed at that time. The house rests on a brick foundation and has a partial basement. It is covered with wide weatherboard siding, and has 6/6 sash windows. Asphalt shingles cover the gable roof.

The corner created by the ell along the facade is filled with a screened-in shed porch. The south elevation of the wing contains a prominent secondary entrance which has been "colonialized" within the past few decades. The north elevation of the wing has a shed addition which fills in the "T" arrangement along this elevation.

The interior has been altered; many original partition walls have been removed to allow for larger sized rooms. One interior feature is of special note - a cast-iron "Catoctin" grate and fireback. It occupies the newer of the two fireplaces, suggesting either that it survives from the earlier house and was moved, or that it was added at a later time.

A garage is situated immediately southwest of the house. It is of log construction and covered with board and batten siding. According to the present owner, Edward Lane, it was used as a sweet potato storehouse in the 19th century, and was used as a temporary dwelling by the Marden family while their house was being rebuilt after the fire. It has been greatly altered in the 20th century for use as a garage. A small apartment occupies the loft space above the garage.

The Marden House is a modest, late 19th century frame, Prince George's County farmhouse which has undergone some alterations.

It appears that a dwelling was constructed on this site c. 1845 during the ownership of Nathaniel Marden of Georgetown.<sup>1</sup> This structure was apparently destroyed in a fire and the present house was built on the same foundation sometime in the 1880s or 1890s. The farm was owned by the Marden/Shreve family from 1845 until 1958.<sup>2</sup>

## 7. Continued

Several feet west of the house and garage is a frame barn/stable, which, according to Mr. Lane, was used in the 19th century to stable horses for the State Department.

An old road bed is visible in front (east) of the house. It ran from Alexandria Ferry Road to Allentown Road, passing in front of the Marden House. Foundations of an unknown structure are visible on the east side of the roadbed.

<sup>1</sup> In an interview conducted in 1978 by Margaret Cook with Edward Lane, the date of construction for the house was precisely fixed at 1894. However, in a more recent interview with Mr. Lane in the summer of 1983, he fixed the date of the fire and reconstruction in the 1880s.

The house is a two-story, frame structure, built on a "T" plan with the west arm of the "T" being an addition. The south chimney is external, with a one story base and a free standing stack. On both floors, narrow 4/4 double hung sash windows flank the chimney. The fireplace grate and fireback were manufactured by the Cotocin Iron Works.

To the south of the house is a log sweet potato barn covered with board and batten siding.


