Description of Property and Eligibility Determination *(Use continuation sheet if necessary and attach map and photo)*

Description:

The residence at 919 Palmer Road consists of a two-story, cross-gable, rectangular plan with minor plan irregularities. It has a 1 1/2-story gable-front entry attached to the front with an enclosed, single-story porch with a hipped roof. Construction materials include brick-patterned, asphalt siding, asphalt roof shingles, and 6/6 windows. This building was constructed in 1911.

National Register Evaluation:

Research has not revealed any association between this structure and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in the past (Criterion B). The building is not a good example of any style; nor is it distinguished; it does not represent the work of a master or display high artistic merit (Criterion C). Although archeology was not addressed in this study, there is not indication that the property is likely to yield information important in history or pre-history (Criterion D). Therefore, this






