The Visiting Officers' Quarters are the single largest military building type at Andrews Air Force Base. They are located on the west side of the base in clusters of three and four buildings. The twenty-two individual structures were constructed in 1946 after the base had been in operation for about three years. Each building was designed to house eight visiting officers, with accommodations for sleeping and assembling, along with both private and shared toilet facilities.

The quarters are one-story tall, rectangular structures built of concrete block. They are basically 87 feet long by 35 feet wide, with two legs, 20' x 15' each, extending from one long side. The original windows were awning, which have been changed to large units of fixed glass adjacent to double-hung sash. The hip roofs on the buildings have pronounced ventilator louvers at each end and projection. The buildings currently have a stucco finish on the exterior, and lack any decorative detail. Since their original construction, the quarters have been modified to accommodate current livability standards for the military, including the installation of private baths for each unit. In addition, the roofs of the buildings have been significantly changed from the original asbestos shingles through the installation of a batten metal roof, changing both the scale and design of the structures.

This grouping of buildings, located on the west side of the base, was constructed in support of the administrative activities associated with base operations and headquarters activities. None of the buildings appear to possess individual character or significance that would meet National Register criteria. They are concrete block construction with gabled roofs. Each was designed to house eight individuals. The floor plans of the buildings have been changed numerous times to accommodate livability standards and code requirements. The exteriors of the buildings have been modified significantly through the introduction of a heavy metal roof which is out of character with the original flat shingle roof. This addition has, in itself, significantly damaged the design integrity of the buildings.

The building fabric has been damaged through the introduction of materials inconsistent with the original design of the structure. In addition, the original setting of the buildings has been changed significantly through the loss of open space and the introduction of military structures and activities immediately adjacent to the structures.


