The Water Storage Reservoir (Building #01835) was constructed in 1943 as part of the second wave of development at Andrews Air Force Base. It is located on the west side of the base, adjacent to North Perimeter Road. The flat roof concrete structure is approximately 116' square with its bottom placed basically at ground level. The side walls of the reservoir are sloped monolithic concrete, forming a solid element with the floor. The exterior grade slopes up to the edge of the reservoir roof, leaving approximately 2' of exposed concrete.

Building #1835 is isolated from any major buildings at Andrews AFB. Its purpose was purely functional, providing water storage for the original base. It is difficult to discern from streets around the site. The structure is not associated with any unique event outside of being part of the development of the base. It is of standard water storage design and construction of the time.


